~~~~~ Understanding Foundation, the ApHC's FPD and GAP Programs, and ICAA's Foundation Division By Sharon January With Helpful Edits By Joanne Jordan

What is a "foundation" horse? A foundation horse is any horse that is or was used during the formation of a registry; any registry. Usually, once a registry is formed, they move away from these foundation horses with each generation, in hopes of breeders producing new generations of horses that get better than the previous. They generally never go backwards in trying to constantly perpetuate these old foundation horses. Why? For one, as already stated, breeders are generally striving to move forward, improving the breed with each generation. But secondly, many times, especially with the older, established registries such as the ApHC and AQHA, it's unknown what the original foundation horses even were. The ApHC and the AQHA originated around the same general time and pulled from the same herds to establish these registries.

There are two myths that run rampant in the Appaloosa world that can be stated in two separate "words": purebred and 100% foundation.

- Currently, there are no purebreds, nor has there ever been, in the Appaloosa world, although we are very close to history being made with the first documented purebred Appaloosa possibly being born as soon as 2025. At 8-generations, the horses in the 8th generation each only contribute 0.39% to the genetic makeup of the horse in question. This is extremely miniscule and the reason that geneticists will consider them purebred at that level.
- There is not and never will be a 100% Appaloosa. Even when purebred status is reached, these horses will still not be 100%. It's impossible to have a 100% Appaloosa when there are so many unknowns and other breeds behind them. The old foundation horses of the ApHC are said to be 100% Appaloosa by some. How can this be when many of those horses were produced from other breeds, and also unknown breeds? You can create a purebred. You cannot create 100% anything when you have unknowns or other breeds in the mix. An old ApHC foundation horse does not make for a 100% Appaloosa.

What is the ApHC's FPD Program? FPD stands for Foundation Pedigree Designation. The name is very misleading. This program has nothing to do with the old foundation horses of the ApHC (which have prefixes of 'F' in their registration numbers). All that's required is that the first four generations of the horse's pedigree have 24 ApHC registered horses to be termed 80% FPD. The higher the percentage, the more registered Appaloosas there are in the first four generations. Generally, when a horse is enrolled at FPD 100%, they are a 4-generation horse (F4) with ICAA as all four generations have registered Appaloosas. **Since the ApHC is only looking at the first four generations, it's clear that this program was misnamed and has nothing to do with the original foundation horses,** but everything to do with how many registered Appaloosas are in those first four generations.

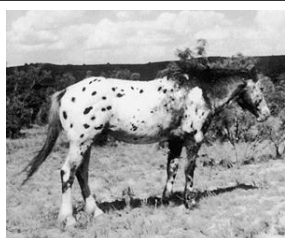

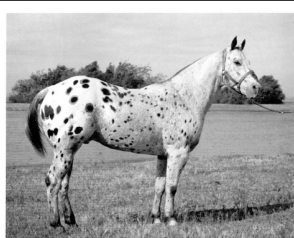
What is the ApHC's GAP program? GAP stands for Generation Advancement Program. The minimum requirement for enrollment in the GAP program is for a horse to have five generations of nothing but registered Appaloosas, starting with the parents as the first generation. The GAP level a horse will be in depends on how many generations of nothing but registered Appaloosas the horse has. For example, there can be no other breed, unregistered, or unknown within all five generations to be a GAP 5. GAP begins at GAP 5; they do not have levels of GAP lower than that, so if it's stated that a horse is a GAP 4 or less, this is not true. The GAP horses are figured in the same way as ICAA figures their F-levels (ICAA's foundation/F-levels will be explained next); they do not count the horse itself as a generation, the parents are the first generation, and each generation must have all registered Appaloosas in the level they're eligible for. Being enrolled in GAP does not mean the horse is considered a "foundation" bred Appaloosa.

What is the ICAA Foundation Division? The ICAA has a division for horses that have from two to seven generations of nothing but registered Appaloosas. These horses have prefixes of F2 through F7, depending on how many generations of registered Appaloosas they have in their pedigree. You can look at an ICAA horse's registration papers and tell how many generations they have by simply looking at their registration number. What is important to note about the ICAA Foundation Division, and a common misconception, is that ICAA's foundation horses have ties to the ApHC foundation horses. They do not. ICAA's horses have absolutely nothing to do with the old ApHC foundation horses, although we see many of them in the higher generation ICAA horses. ICAA's foundation horses are the building blocks to the future purebred horses that will be placed in the Purebred Division (once ICAA reaches an 8-generation horse, this division will be opened and the horse will get a prefix of P8, still stating how many generations of registered Appaloosas these horses have by the number beside the 'P').

What is a "foundation" horse? A foundation horse is any horse that is or was used during the formation of a registry; any registry. Here are some examples of ApHC foundation Appaloosas. Please note the breed of each horse's parents.

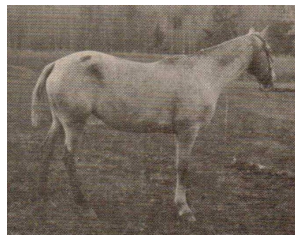

ICAA Horsemanship Program

As a reminder, all enrollees in the ICAA Horsemanship Program are required to send an Update Form at the first of the year. This form lets us know if there have been any changes, such as adding a new handler, or for a new owner (the hours go with the horse and when sold the seller should include the hours accumulated with the paperwork the buyer receives). These forms are fillable and available on the ICAA website's Forms page.

Remember, we also have the Open Show Point Program, Competitive Trail Riding Program, and the Production Achievement Awards Program. All of these can be researched on the ICAA website on the Programs page and any forms necessary are on the Forms page.

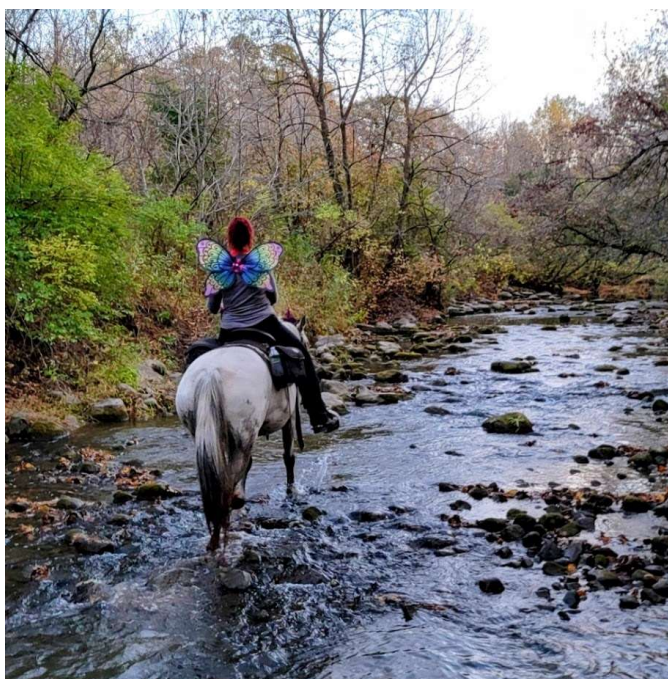

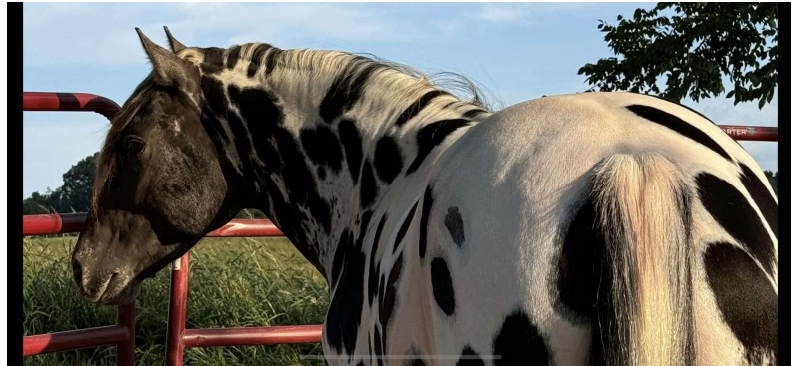
