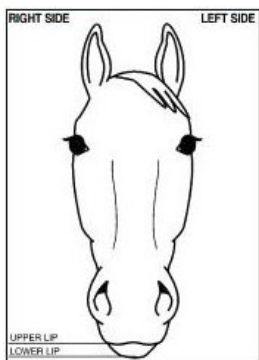
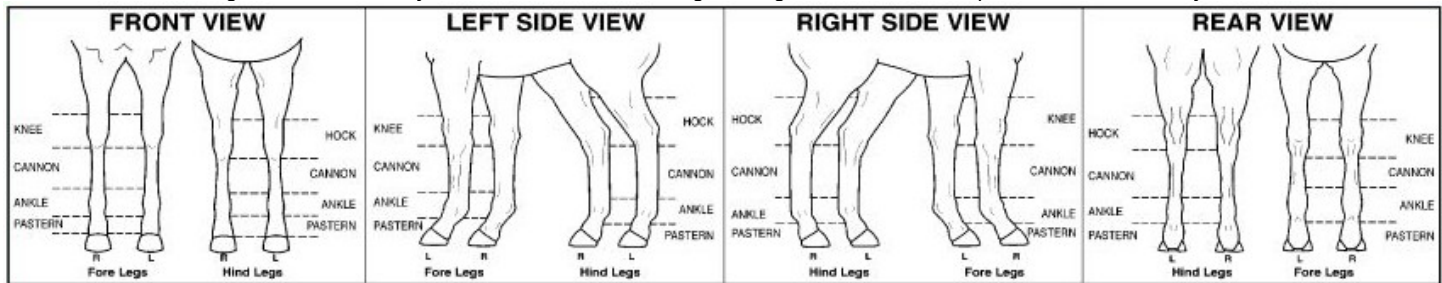

All four legs should be clean and showing in each of these four photos, including hooves. Extra photos can be submitted where more close up details may be needed (and may be required). Photos are to be between 3 1/2 x 3 1/2 inches and 3 1/2 x 5 inches with the horse filling most of the frame and without any body parts cut off. Label the back of each photo with the following: Date taken, horse's pending name, sex, sire and dam's name and numbers, owners name and membership number if known.

If a horse is carrying two dilution genes, please check off both colors above that apply.  
 Example: A dunalino (dun/palomino) would have both red dun and palomino checked off.
