i. <u>Landscaping</u>. No weeds, underbrush, or other unsightly growth shall be permitted to grow or remain upon any Lot, and no refuse or unsightly objects shall be allowed to be placed or suffered to remain upon any Lot. All landscaping, sprinkler systems and any property, structure, improvement and appurtenance shall be kept in good, safe, clean, neat and attractive condition. The grassed area of Lots are Areas of Common Responsibility to be maintained by the Association unless it designates otherwise, provided, however that if the Owner constructs or allows to be constructed a fence or other improvement that encloses a portion of the Lot, the Association is relieved of all maintenance responsibility for such enclosed area and the same shall revert to the maintenance responsibility of the Owner of the Lot
