NAPLES RESERVE HOMEOWNERS ASSOCIATION POOL RULES REVISED SEPTEMBER 14, 2022

THERE IS NO LIFEGUARD ON DUTY. ALL PERSONS USING THE POOL DO SO AT THEIR OWN RISK.

The Naples Reserve Homeowners' Association, Inc. (herein referred to as the "Association"), Management and Staff assume no responsibility for any accident, personal injury or for any loss or damage to personal property arising out of, or in connection with the use of the pool or pool area. Pool area is defined as "Inside the fence line all around the perimeter of: the Island Club, pool, tiki hut, bocce courts and beach."

1. Hours of Operation

a. Per Florida Department of Health State Statute 64E-9.008 (8), swimming is permitted one half hour after sunrise and can continue throughout the day until one half hour prior to sunset.

2. General Use Requirements

- a. All persons are required to abide by these rules at all times.
- b. Use of the pool / pool deck area is limited to residents of the property plus their eight (8) guests per unit. Maximum number of persons per household is 10.
- c. No glass objects of any kind allowed inside the Pool Area.
- d. Please use the outside pool gates to gain access to the pool area. Do not access the pool through the Island Club or the Fitness Center. Please be sure all pool gates are securely closed.
- e. No person wearing wet clothing permitted inside the Island Club, Fitness Center, and Outrigger.
- f. The following areas always require shoes, shirt or coverup to be worn: Island Club, Fitness Center, and Outrigger.
- g. During lightning and/or thunderstorms, the pools and pool areas must be vacated immediately.
- h. The Association and Management will not be responsible for any belongings lost or stolen
- Any violation of these rules should be reported to management or staff giving complete details of the incident verbally or in writing. Management will investigate each incident, take such corrective actions as deemed necessary and possibly report to the Board of Directors.

3. Age of Use

- a. No one under the age of eighteen (18) is permitted to use the pool unless accompanied by an adult, parent, or legal guardian. Persons ages 16 and 17 may use the pool without supervision when a signed waiver is on record in the management's office.
- b. All incontinent swimmers must use swim diapers and leak proof pants.
- c. The infant wading pool is for persons 7 years of age and under.

4. Conduct

- a. Radios, tape recorders, CD players or any other personal audio device may only be used with headphones. Exception to the rule is for approved Fitness Classes conducted at the pool.
- b. Diving, running, jumping, pushing, wrestling, ball playing, Frisbee throwing or any other activity that creates a danger or nuisance to others is prohibited. Do not jump from or climb on waterfall or rocks. No yelling or profane language allowed.

- c. Owners, lessees, and guests shall conduct themselves in a manner that does not unreasonably disturb or annoy other persons in the pool area.
- d. No tobacco smoking, chewing, vaping, marijuana smoking, or illicit drug use is permitted. All of Naples Reserve Common Areas are Tobacco Free as we are Blue Zone Property.

5. Food/Beverages/Alcohol

- a. No food, drink or pool furniture are permitted within 4 feet of the pool edge.
- b. No food or drink is allowed in the pool at any time.
- c. Outside food and beverage is not allowed at any time during the operating hours of our Food and Beverage vendor's hours of operation.
- d. Any day our Food and Beverage vendor is closed for business (typically Mondays) outside food and beverages will be permitted in the pool area. Please remember no glass objects of any kind allowed inside the Pool Area.
- e. Containers, coolers, and lunch bags may be inspected by Management and Staff to ensure no glass are carried into pool area.
- f. The barbecue may be used on a "first come first serve" basis during any day our Food and Beverage vendor is closed for business (typically Mondays). You must bring your own food, flippers, foil, plastic or paper goods/utensils and other non-glass cooking implements in order to use the on-site barbecue.
- g. Residents and Renters using the barbecue must fully clean it after use and report to Management and Staff of any repairs or problems noticed.
- h. No personal cooking devices of any type (personal grills, crock pots, warmers, etc.) is permitted anytime / anywhere in the pool area.

6. Lap Pool

- a. The lap pool is available for lap swimming only.
- b. No hanging on Lane Rope unless for safety reasons.

7. Pets

- a. No pets or animals allowed in the swimming pool or on the pool deck, or in the facilities except for service animals.
- Pets cannot be walked or carried through any area of the pool deck at any time, except for service animals.

8. Pool Furniture

- All pool furniture including loungers, chairs, tables, chairs and umbrellas provided on a first-come, first-served basis. Furniture cannot be reserved by leaving personal items such as towels on chairs, loungers, or other furniture.
- b. In the event you leave the pool area (as described above) for any reason, your personal items must be removed from your chairs, loungers, and tables, making them available to the next resident and/or guest.
- All pool furniture must remain in the pool deck area and cannot be moved to other areas of the property at any time. This includes areas such as the beach and Bocce courts.
- d. Umbrellas will be lowered and/or removed from the general pool area during high wind forecasts or severe weather conditions.
- e. Pool furniture must be returned to its original location, umbrellas must be lowered and secured.
- f. Pool furniture and equipment shall not be modified, altered, or changed in any manner.
- g. Additional personal beach chairs, tables, loungers, or other personal furniture items are not permitted within the pool deck gated area due to seating capacity limitations from the Fire Marshall.
- h. Personal folding beach chairs only are allowed on the beach area.

9. Sanitation

- a. Prior to entering swimming pool, all persons are encouraged to utilize the poolside shower to properly rinse and remove all sand, oils, and other foreign materials. No soaps or shampoos are permitted at the poolside shower.
- b. No person may enter the swimming pool with an open wound or any contagious conditions or infection. Management has the right to make a judgement regarding any person's fitness to enter the pool.
- c. Diaper changing is ONLY allowed in the restrooms where there are changing tables available.
- d. Any fecal contamination must be immediately reported to staff/Management.

10. Toys/Rafts, etc.

- a. Toys, floats, rafts, surfboards, and air-filled devices are not permitted in the main large pool at the Clubhouse.
- b. Small floating "noodles", personal Coast Guard approved lifesaving devices, and floatation devices attached to and used by people as a safety device are permitted to be used including waist and arm floatation devices.
- c. Small personal toys are permitted in the infant wading pool area and on the beach.

11. Wheels

- a. Only wheelchairs, wheeled medical devices, and strollers are permitted on the pool deck.
- b. Bicycles, skateboards, scooters, roller blades, roller skates, Segway and other such wheeled devices are not allowed inside the gated area of the pool deck.
