POOL UPDATE

Dear Naples Reserve Residents,

The Island Club pool will be closed Monday, October 24th to Friday, October 28th due to a much needed acid wash. The acid wash will remove the staining at the bottom of the pool and keep the finish beautiful and bright! We thought carefully about the timing of the closure as we know it will inconvenience many. With the cold front next week, the pool heater still being fixed, and no entertainment scheduled, we thought it would be a good time to get this treatment done before high season.

Please note that the Tiki Bar, Island Club, Fitness Center, and Watercrafts will remain open during this time. It is only the pool that will be closed.

Pool heater update:

The pool heater control panel was submerged in water during the hurricane. A technician was on site on Wednesday and has ordered the parts needed. Replacing the panel is the first step of the repair. They are hoping to have the parts next week. We are pushing to have this fixed as quickly as possible. We apologize for the inconvenience.

LIVING WITH ALLIGATORS

68A-25.001 FEEDING OR ENTICEMENT OF CROCODILIANS UNLAWFUL.

No person shall intentionally feed, or entice with feed, any crocodilian unless held in captivity under a permit issued by the Fish and Wildlife Conservation Commission or otherwise provided by this Title.

Rulemaking Authority Art. IV, Sec. 9, Fla. Const. Law Implemented Art. IV, Sec. 9, Fla. Const. History–New 3-1-05, Amended 5-18-06.





Enjoy these amazing creatures from a safe distance, at least 30 ft. and always keep the following points in mind:

- DO NOT FEED ALLIGATORS! It is against the law and it causes alligators to lose their natural fear of humans
- DO NOT HARASS ALLIGATORS! It is against the law and it causes alligators to become very defensive/aggressive!
- DO NOT feed ducks, turtles, fish, or other wildlife. This can draw alligators, as well as other predatory animals to the area.

KEEP a safe distance & always keep your pets on a leash. Alligators can, and will, lunge/run.


