# REGULATIONS & COLORS & COLORS

- Disciplinary Responsibility: Forever Xclusive is not responsible for disciplining athletes for actions or behaviors outside of the program.
- Transportation and Travel: While the Forever Xclusive staff
  is committed to being accommodating, they are not
  responsible for taking athletes to and from practices,
  competitions, or arranging travel for events.
  - Customer Service Commitment: We are dedicated to providing exceptional service and support to all our clients, ensuring a positive and professional experience.
- Threatening to Quit: Any athlete or family member threatening to quit the program will be asked to leave immediately. No refunds will be issued.
- Assumptions: We encourage open communication. Please refrain from making assumptions about any programrelated matters. Always feel free to ask questions if you are unsure.
- Attitude and Behavior: A positive attitude is essential for success in our program. If an athlete displays a poor attitude, they may be placed in a non-competitive program, such as a class, or placed on probation until further notice. Athletes may be asked to leave the program if their attitude does not align with the standards of Forever Xclusive.
- Communication: Please refrain from calling or texting staff unless it is an emergency. All non-emergency communication should be conducted through the BAND app.
- Cell Phone Use: All cell phones must be turned off during practices. Any phone usage should be limited to before or after practice.
- Belongings: All clothing and personal items must be stored in cubbies, not left on the floor. This is the athletes' second home, and we ask that everyone treat the space with respect.
- Lost Items: Forever Xclusive is not responsible for lost or stolen items, including cell phones, jewelry, or other personal belongings. We will not provide compensation for any lost items.
- Punctuality: Timeliness is crucial. Athletes should arrive at least 5 minutes early to all functions. On-time arrival means being in front of the coach at the designated meeting time.
- Mandatory Extra Practices: Extra practices may be scheduled for the benefit of the team and are mandatory for all athletes.
- Hair and Nails Policy: For safety reasons, long nails and excessively long or heavy hairstyles are not permitted during practices or competitions.

- Siblings in the Facility: Siblings of athletes are not permitted to watch or play inside the gym or be left unattended during practices. We are unable to provide childcare services.
- Discipline and Behavior: No one is allowed to yell onto the floor or attempt to discipline athletes from the lobby. We ask that all spectators respect the boundaries of the gym and its operations.
- Use of Name and Logo: The use, sale, or production of items featuring the Forever Xclusive name or logo is prohibited for copyright reasons.
- Access to the Gym: Only staff and athletes are permitted in the gym. All spectators must remain in the lobby for the duration of practices.
- Gossip and Negative Commentary: It is never appropriate to gossip about other athletes, parents, or teams. We encourage a positive and respectful environment for all.
- Respect for Professional Staff: Your input regarding practices, routine composition, skills in routines, choreography, team meeting times, practice schedules, and competition schedules should be directed to the professional staff. We trust their expertise and decisions in these matters.
- Dress Code: A dress code will be enforced each season. Any athlete arriving in incorrect attire will be provided with a new outfit, and the parent's card on file will be charged for the items.
- Footwear: Proper shoes must be worn during practice at all times.
- Absences: Any absences must be cleared by the Head Coach and signed off by management.
- Closing Practices: Coaches reserve the right to close practices at their discretion.
- Discipline and Team Unity: Withholding an athlete from practice as a form of discipline is not acceptable.
   It is unfair to the team and disrupts group dynamics.
- Social Media Conduct: Negative comments, routines, or music should not be posted online. Always maintain professionalism in your online interactions.
- Sportsmanship and Professionalism: Always exemplify good sportsmanship and professionalism, both in and out of the gym.
- Language Policy: Profanity or rude language will not be tolerated under any circumstances.
  - Disturbances: Any athlete or parent causing a disturbance to the program will be asked to leave immediately, with no refunds issued.
- Chain of Command: If you have a question or concern, please follow the established chain of command:
   Team Representative → Front Desk → Gym Director → Head Coach.

### POLICY

Any parent or individual observed speaking negatively about a team, coach, parent, or athlete will be addressed accordingly. The individual may be spoken to and/or asked to leave the premises. Should this behavior persist, the athlete associated with the individual may be removed from the team. We have a zero-tolerance policy for such conduct.

In the event of verbal assault or threats directed towards a student, coach, or another parent, the family involved will be immediately dismissed from the program, with no refund issued.

At all competitions, parents and fans are expected to uphold a positive and respectful image for the Forever Xclusive program. Any individual causing a disturbance, whether through disruptive behavior, negative comments, or inappropriate actions, will be asked to leave the event. Such behavior may also impact the athlete's position in the program.

All transportation and accommodation expenses for competitions are the sole responsibility of each family. These fees are not included in the team payments. While we will make every effort to provide competition details in a timely manner, Forever Xclusive will not be held responsible for any reimbursement in the event of a competition being cancelled or rescheduled, for any reason.

We deeply value the dedication and support that parents provide, as it plays a crucial role in the success of our athletes. We strongly encourage all parents to unite in their support of all teams, fostering a positive and inclusive environment. Additionally, parents are invited to demonstrate their support by wearing Forever Xclusive apparel at competitions.

It is expected that all parents uphold a high standard of respect towards the coaching staff, fellow teams, and host organizations. As representatives of Forever Xclusive, it is essential that we maintain professionalism and courtesy at all times, ensuring a positive atmosphere for both athletes and spectators alike.

# FEES STATE

All monthly payments will be charged to your account on the 25th of each month. Payments must be received within 10 days of the invoice being issued. Any payments not received by the 11th day will incur a \$25 late fee. This applies to all partially paid invoices.

A \$15 late fee will be assessed for any shoeduled payments deliquent by a 5 day period. All other fees must be paid by their respective due dates.

Accepted methods of payment include cash, check, credit card, or money order. Parents or responsible adults will be required to sign a financial contract, and each signatory will be responsible for ensuring their child's account remains current.

Any athlete whose account is one month overdue will be suspended from practices until the balance is settled. If an account remains unpaid for three months, the athlete will be removed from the competition program. Full financial responsibility for all payments remains with the signatories of the contract. Please note that monthly tuition cannot be prorated under any circumstances.

Additionally, tuition, choreography, camp, and competition fees are non-refundable.

Parent Pick-Up Policy

Athletes must be picked up no later than 10 minutes after the gym closes. A fee of \$10 will be added to the athlete's account for every additional 30 minutes beyond this time. This policy may be waived in cases of emergency. Athletes may not be dropped off more than 15 minutes prior to their scheduled practice time without incurring a babysitting fee of \$25.

## Fundreising

Forever Xclusive has a member based non profit that requires a membership fee.

Fundraiser will be presented every monthly. Your fundraising profits unless noted will be directly posted to your account. This involves extra work outside of cheer. However, we have seen people pay for their whole year through fundraising!

# ATHLETE POLICY

### **ABSENCES**

Attendance is critical to the success of the team. All unexcused absences will be documented. If an athlete accumulates two or more unexcused absences, a \$75 fee will be applied. Missing more than three practices will result in removal from the competition routine and placement on probation. Missing four or more practices will result in removal from the program, with no refund, and the full season obligation will remain due at the time of dismissal.

### UNIFORMS & ATTIRE

Please maintain all Forever Xclusive clothing, warm-ups, and uniforms in good condition. Any lost or damaged uniform items should be reported to the front desk. The cost of replacement will be the responsibility of the athlete. Athletes are required to wear assigned gear to practice (no jeans or jean shorts). Jewelry is not permitted during practice. Items not included as part of the official uniform must receive prior approval before being worn at competitions (e.g., hairpieces, headbands, or hairstyles outside of program guidelines).

#### DISCIPLINE

If any of the above rules are violated, the following steps will be taken:

- 1st Violation: A meeting with the athlete to discuss the issue.
- 2nd Violation: A meeting with the athlete and parent, followed by a discipline contract.
- 3rd Violation: Removal of the athlete from the team, and possibly the program.

  Any athlete involved in illegal activities will be immediately dismissed from the program.

### Injury

In the event of an injury, it is the parent's responsibility to seek professional medical assistance. Each athlete must have their own medical insurance. After seeing a physician, a written evaluation of the athlete's injury and status must be provided. A release from a doctor is required for any serious injury. Athletes are still responsible for fulfilling their financial obligations based on the time of season when the injury occurs.

### EXCUSED ABSENCES

- -Contagious illness.
- -School function that affects grade.
- -Family emergencies.
- -Vacation during summer.

Vacations are not permitted during competition season, unless the gym is closed and the athlete has already cleared it with program director. Also, any vacations must be in requested in writing at the bringing of the season.

- IT IS MANDATORY FOR ALL ATHLETES TO ATTEND PRACTICE AT LEAST TWO WEEKS PRIOR TO A COMPETITION. MISSING PRACTICES DURING THIS CRITICAL PERIOD IS DETRIMENTAL TO THE TEAM'S SUCCESS AND WILL RESULT IN THE FOLLOWING FEES:
- FEES FOR MISSING PRACTICES:
- \$250 FEE FOR MISSING ANY PRACTICE WITHIN TWO WEEKS PRIOR TO A COMPETITION.
- \$500 FEE FOR MISSING ANY PRACTICE DURING THE WEEK OF THE COMPETITION.
- \$750 FEE FOR MISSING BOTH WEEKS OF PRACTICE, RESULTING IN THE ATHLETE'S REMOVAL FROM THE COMPETITION ROUTINE UNTIL ALL FEES ARE PAID.
- PAYMENT FOR MISSED PRACTICES:
- ALL FEES MUST BE PAID WITHIN TWO WEEKS AFTER THE COMPETITION. IF FEES ARE NOT PAID WITHIN THIS PERIOD, THE ATHLETE WILL REMAIN OFF
  THE TEAM UNTIL THE BALANCE IS SETTLED.
- PROGRAM DEPARTURE FEES:
- IF YOU DECIDE TO LEAVE THE PROGRAM FOLLOWING YOUR ATHLETE'S DISMISSAL FOR MISSING PRACTICES BEFORE A COMPETITION, YOU WILL BE SUBJECT TO THE QUITTING FEE ALONG WITH ANY REMAINING FINANCIAL OBLIGATIONS FOR THE SEASON.

Competitors are responsible for staying to watch every Forever Xclusive team for the ENTIRE competition. We are a family and a family needs to support one another. Any family caught repetitively not supporting other teams will be ground for an account charge fee of \$100 per event.

# Forever Xclusive LOOK

- Uniform Standards: All athletes, regardless of race, age, or gender, are expected to adhere to the professional appearance standards set by Forever Xclusive.
- Dress Code: Athletes must follow the designated dress code as outlined by the program director. This includes adhering to assigned hairstyles, which must be in accordance with the team's specified style.
- Forever Xclusive Look: All athletes must arrive at practices, competitions, and events with the "Forever Xclusive Look." This standard is non-negotiable.
- Consequences for Non-Compliance: Any athlete who arrives with an incorrect hairstyle or makeup will receive a warning. A second offense will result in a fee being charged to the athlete's account.
- Pride in Appearance: It is unacceptable for an athlete to arrive at any event without the
  Forever Xclusive Look. Please take pride in your athlete's appearance. It reflects not only on
  your family but also on the reputation of the program. Arriving looking unprofessional is
  detrimental to both the individual athlete and the team.

#### FINANCIAL OBLIGATION CONTRACT

I (parent/guardian) agree to be solely responsible for the financial commitment. Al payments are non- refundable and non- transferable. Payments are never pro-rated/refundable Including cases of illness/injury, sitting-out joining late or leaving early.Pay-in-full prices are

discounted and therefore nonrefundable This agreement ("Agreement") is entered into between the undersigned, (referred to as "Parent" or "Guardian") and Forever Xclusive LLC, and applies to the athlete named below (the "Athlete"). By signing this document, you, as the Parent or Guardian, agree to abide by the terms and conditions set forth in this contract for the Initial duration of the program. 1.Payment and Charges: I acknowledge and agree that all team payments will be charged to my account on the 25th of each month for the upcoming month's payments. I understand that if my balance is not paid by the end of each month, my card on file will be charged for any remaining balance. 2. Late Fee and Declined Transactions: I acknowledge and agree that I am subject to a late fee of \$25 if my card is declined. I understand that declined transactions will result in the athlete being suspended from practice until the balance is paid in full. I further acknowledge that I have 5 days to resolve any balance to allow my athlete to participate 3. Authorization for Charges: I, the undersigned, give Forever Xclusive LLC authorization to charge my credit/debit card for the fees outlined above, as well as any other fees related to the athlete's participation 4. Dismissal from the Program: I acknowledge and agree that if I or my athlete is dismissed from the program for any reason, no refunds will be issued. I remain financially responsible for any unpaid charges for the season, including the remainder of my financial obligations for the current season. If payments are not made, I acknowledge that my account information may be sent to a third-party collection agency for 5. Program Buy-Out and Withdrawal: If I choose to leave the program prior to May 30th, 2024, I will be subject to a \$500 buy-out fee, plus any remaining financial obligations for the season, including fees already paid and ordered items. All fees posted to my account must be settled within 7 days of leaving the program. I understand that Forever Xclusive LLC reserves the right to pursue delinquent accounts through small claims court, and any additional court fees, travel fees, or time inconvenience fees will be added to 6. Late Arrival and Pick-Up Fees: I acknowledge and agree that if my athlete is late for practice, events, or competitions, a \$20 fee will be applied for each occurrence. I further agree to pick up my athlete on time after practices, events, classes, and competitions. If my athlete is not picked up on time, a \$50 babysitting fee will be added to my account. Additionally, I understand that athletes should not be dropped off more than 15 minutes early for any scheduled event. Excessive early drop-off will also result in a \$50 babysitting fee. 7. Customer Relations Fee: I acknowledge and agree that if I become a difficult customer requiring constant attention or reminders about events, practice times, or program rules, or if I neglect communication with the program, a \$100 fee may be added to my account. 8. Program Authority and Attendance: I acknowledge and agree that Forever Xclusive LLC has full authority to make final decisions regarding travel, fees, team placements, and dismissals. I understand that no athlete is allowed to miss practice within two weeks before a competition or event. Fees for missing practices are as follows: \$250 for missing any practice within two weeks prior to a competition or scheduled event. \$500 for missing one week prior to a competition or scheduled event. \$750 for missing both weeks, with removal from the competition routine until all fees are paid. All fees must be paid within 7 days after a competition, and an athlete will not be allowed to participate in further events until all fees are paid. 9. Suspension for Non-Payment: I acknowledge and agree that if fees are not paid, my athlete will remain off the team until the account is brought current. If I decide to leave the program due to dismissal for missing practices before a competition, I will be subject to the \$500 buy-out fee and will remain financially responsible for the full season's financial obligations. Additionally, a \$300 fee will be applied at the end of the season if any balance remains after the start of the next season. 10. Season Cancellation or Pause: I acknowledge and agree that if the season is paused or canceled for any reason, I am still financially obligated to complete my payments up to the final date of the program's dismissal. I also understand that I am responsible for any remaining balances for items, competitions, or other fees already paid for. Tuition fees will be assessed at the time of season cancellation.
