## *Rules & Regulations*

**Booth Activities & Demonstrations** • The exhibitor is permitted to demonstrate the firm's equipment and to make informal presentations regarding the product line or service at the table. Noise level must be kept at a minimum as to not disturb neighboring exhibitors and attendees.

Exhibit booth personnel will be provided with advance notice if it becomes necessary to change the exhibit space floor plan or alter exhibit show hours that will benefit the NATI attendees.

**Hours** • Exhibitors and sponsors are encouraged to set up their tables on Sunday, April 17 from 1:00 pm to 5:00 pm. The exhibit hall will be open from 8:00 am to 5:00 pm, Monday through Thursday. Show hours are 8:00 am to 5:00 pm; the powwow will be held on Thursday, April 21 therefore arts and crafts vendors may stay set up through that event.
