ACKNOWLEDGMENT OF RISK, RELEASE OF LIABILITY, AND INDEMNITY AGREEMENT

FULLY UNDERSTAND, ACKNOWLEDGE, AND AGREE that I have voluntarily applied to participate in, or to observe firearms shooting, firearms training and firearms events at the NORTH HOLLYWOOD SPORTSMAN'S CLUB (hereafter referred to as the "NHSC"). I further UNDERSTAND, ACKNOWLEDGE, AND AGREE that firearms shooting, firearms training and firearms events "include any and all activities of any kind whatsoever in which I engage while at the NHSC range, whether sponsored by the NHSC or not, and which also includes any travel to or between stages or ranges or while waiting my turn to shoot or observing other in the act of firearms shooting.

I FURTHER FULLY UNDERSTAND, ACKNOWLEDGE, AND AGREE that by their very nature, the use of firearms, training, and observation of use is dangerous and inherently hazardous, and that accidents which occur while participation in firearms use, training, and observation of use can result in damage to property, serious injury, and even death, and involve both known and unknown, unforeseeable and unanticipated risks which could result in damage or destruction of personal property and physical or emotional injury, or other injury to myself or of other persons. The risks inherent in participating or observing firearms activities include but are not limited to being shot by others, shooting myself or others, partial or total loss of eyesight or hearing; inhalation or absorption or other harmful contact with lead or other contaminants; and being struck by flying or falling objects. I UNDERSTAND THAT SUCH RISKS ARE INHERENT IN THE ACTIVITY AND CANNOT BE ELIMINATED WITHOUT COMPROMISING THE ESSENTIAL QUALITIES OF SHOOTING ACTIVITIES.

I FURTHER UNDERSTAND, ACKNOWLEDGE, AND AGREE that the nature and condition of the NHSC facilities, premise, and environments are such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent in entering onto the NHSC facilities, premises, and activities of any kind, whatsoever while at the NHSC facilities, premises, or environments. These hazards my include but are not limited to: slippery, loose, or falling soil and rocks; unimproved, unmaintained, or uneven terrain, walkways, steps, pathways and roads; poisonous or dangerous plants, snakes, insects, or other animals; and falling tress, tree branches, and other debris. I UNDERSTAND THAT SUCH RISKS ARE INHERENT IN THE ACTIVITY AND CANNOT BE ELIMINATED WITHOUT COMPROMISING THE ESSENTIAL QUALITIES OF RANGE FACILITIES EQUIPMENT, PREMISES, AND ENVIRONMENT.

I FURTHER FULLY UNDERSTAND, ACKNOWLEDGE, AND AGREE that the NHSC makes no warranty as to design, manufacture, maintenance, condition, or fitness for any particular purpose of any NHSC premises, facilities, environment, or equipment, including but not limit to: firearms, ammunition, eye/hearing protection, first-aid supplies, range facilities, or maintenance equipment.

AS LAWFUL CONSIDERATION for having been permitted by the NHSC to participate in these activities and/or observe said activities and use in the NHSC facilities, premises, and environments, I HEREBY AGREE THAT I, being lawful age, and my heirs and assigns shall release, acquit, and forever discharge NORTH HOLLYWOOD SPORTSMAN'S CLUB and their agents, servants, successors, heirs, executor, members, board members, administrators, and all other persons, firms, corporations, associations, or partnerships, affiliated organizations and attorneys and insurance provider, of and from any and all claims, actions, causes of actions, demands, right, damages, cost, fees, attorney fees, loss of service, expense and compensation, of any nature whatsoever, may hereafter accrue on account of, or in any way grown out of any and all know and unknown, foreseen and unforeseen, indemnity action, contractual action, bodily and personal injuries and property damage and the consequences thereof resulting, or to result from my participation in, or observation of shooting activities or use of the facilities, premises, and environments of the NORTH HOLLYWOOD SPORTSMAN'S CLUB and on behalf of my heirs and assigns hereby also agree to INDEMNIFY AND HOLD HARMLESS there herein above referenced parties, entities from any and all claims, action, causes of action, demands, rights, damages, costs fees, attorney fees, loss of service, expense and compensation, of any nature whatsoever, as may hereafter accrue on account of my or my quest's participation in, or observation of, shooting activities of use of the . premises and environments of the NORTH HOLLYWOOD SPORTSMAN'S CLUB even if such claim, demand damages, expenses, causes of action, or liability results wholly or partially from any acts or omissions to act, even negligent acts or omissions to act by the NHSC.

AS A GUEST, I EXPRESSLY AGREE to assume responsibility and liability for any act, or omissions to act, including reckless, negligent, malicious, or criminal acts for myself and/or any minor(s) under my custody while a guest at the NORTH HOLLYWOOD SPORTSMAN'S CLUB (the term"guest" shall include any or all persons who are not members of the NORTH HOLLYWOOD SPORTSMAN'S CLUB who enter onto the NHSC premises, facilities, or environments for use of the range, observation of shooting activities, or other activities) I acknowledge that I have carefully read this ACKNOWLEDGMENT OF RISK, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT.

I FULLY UNDERSTAND, ACKNOWLEDGE, AND STATE that I am not restricted from owning/possessing or operating any Firearm due to Local, State or Federal restrictions for any purpose or reasons.

This agreement shall be interpreted and enforced under the law of the state of California.

Should any portion of this agreement be deemed to be invalid under the laws of the state of California, I agree and intend that the remaining portions shall remain in full legal force and effect.

I have carefully read the entirety of this document and am signing it of my own free will and with no additional inducements and understand that in signing it I may be giving up substantial rights in that I am agreeing not to sue the NORTH HOLLYWOOD SPORTSMAN'S CLUB and am releasing it and agreeing to indemnify and hold it harmless.
