

United Way of Greater Warren County (UWGWC) ALLOCATIONS GRANT APPLICATION, Fall, 2022 DEADLINE August 29, 2022, 5. p.m., CST

This grant is open to eligible nonprofits serving residents living in Warren, Henderson, and/or Mercer Counties and reflects the second grant opportunity for the 2022 calendar year for United Way of Greater Warren County. Applications will be awarded based on eligibility, assessed need, and community impact.

Priority will be given to:

- Organizations, who due to capacity constraints, have been unable to secure funding from other opportunities;
- Organizations who have not received funding for the 2022 calendar year;
- Organizations specializing in inclusion, arts, or other programming, with limited opportunity for regular State, Corporate, or Federal, or other special funding.

Not every organization is guaranteed grant funding. Awards will be announced when funds are distributed the week of September 26, 2022. All organizations applying for funds MUST complete ALL criteria for this award *prior* to the grant deadline.

INSTRUCTIONS:

Your complete grant submission MUST be sent electronically in one grant submission packet as a PDF file by deadline to adminuwgwc@wcunitedway.org. Any accompanying criteria must have verification of completion with the packet submitted. ELIGIBILITY:

Grants are made to nonprofit organizations who have been serving Warren, Henderson, and/or Mercer counties for three or more years. Nonprofit organizations funded primarily through tax support are not eligible. Any nonprofit who is NOT an organization currently funded by United Way of Greater Warren County may need to provide additional information, if requested.

PLEASE READ CAREFULLY. ALL ITEMS BELOW MUST BE CONTAINED IN YOUR GRANT SUBMISSION

PACKET. Funds are available for programming, individual projects, capacity building, or equipment necessary for implementing eligible programming.

- -Organization's most recently filed 990 and audited financial statement.
- -List of current board of directors, including contact information.
- -Contact information for individual(s) responsible for grant submission, including email and phone number.
- -A letter explaining the organization's <u>specific need for requested funding</u>, including the title, purpose, <u>amount of funds requested</u>, as well as a <u>detailed budget related to funding request.</u>
 -<u>IF APPLYING FOR A PROJECT OR EQUIPMENT</u>, include a list of all other entities providing funding and/or matching grants.
- -<u>IF APPLYING FOR FOR GENERAL PROGRAMMING</u>, please also include a list of all additional COVID-related, government, or other grants received, or anticipated, for this programming.

ADDITIONAL INSTRUCTIONS:

- -Organizations currently funded by UWGWC are required to provide either qualitative or quantitative information SPECIFIC TO THE FUNDING FOR WHICH YOU ARE APPLYING.
- -Grants awarded must be used for the project, equipment, or programming outlined in this application and you will be asked to have detailed documentation of such available upon request.
