An ordinance levying taxes for all road purposes for South Grove Township Road District, DeKalb County Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of South Grove Township, DeKalb County, Illinois as follows:

SECTION 1: That the Highway Commissioner of South Grove Township Road District on _____ does hereby determine and declare that the sum of **One Hundred Fifty-Seven Thousand Six Hundred Seventy Dollars (\$157,670)** are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2026.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


