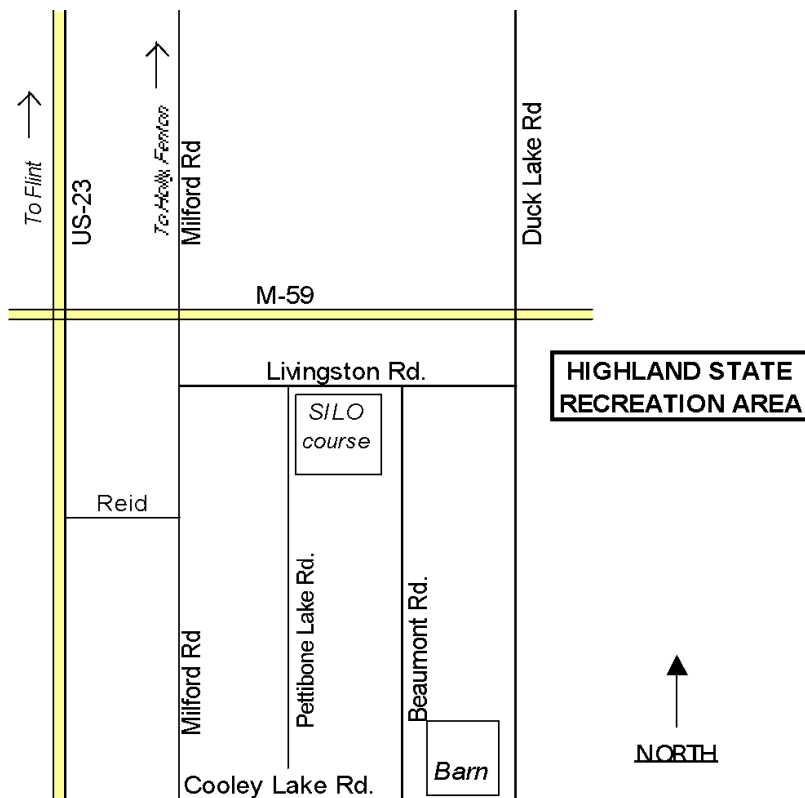

## DIRECTIONS TO THE GROUNDS

Highland Recreation Area, Silo Course, is located on Livingston Road between Pettibone Lake Rd. and Beaumont Rd. Livingston Road is south of M-59, running East/West between Milford Rd. & Duck Lake Rd.

**NOTE: A Michigan State Park permit is required** for every Motor Vehicle to park on the grounds. Permits may be bought at the grounds.

**THIS TRIAL WILL BE RUN DURING DAYLIGHT HOURS.** This trial is being run under the Flexible Format. The Field Trial Committee reserves the option to rearrange the schedule of stakes and add or subtract judges if conditions warrant. Stakes with less than four entries will be cancelled. No more than 50% of the dogs entered in each stake may be handled by the same person. No entry confirmations will be sent.

Dogs that first qualify at this trial will not be permitted to enter the Limited Stakes. No refunds for entries cancelled after closing.

**Note:** \$3.50 from each entry is applied to the AKC Recording and Event fee, and \$3.00 from each entry is donated to the Highland Field Trial Grounds Association.

## COURSES AND BIRDS

- All Stakes will be run on a course without a bird field.
- Quail will be released in all stakes except Open Puppy and Amateur Walking Puppy Stakes.
- Horseback handling is not permitted in the Amateur Walking Stakes.
- No guns in Puppy Stakes.
