Payouts for 1/3 of Golfers in each Flight  
Gross and Net CWGA Champions  
All Handicap Levels  
Amateur Golfers with USGA Handicaps  
Golfers may have higher handicaps,  
but must play to 32 for Events

### TEAM GOLF (Voluntary)

Minimum of two Golfers from each Club  
Cumulative Scoring over the Season  
At each Event – top two Gross and top two Net  
\$50 one-time fee before November 1  
Club Designation per Membership Application  
No Club Changes after November 1  
Team Payouts and Traveling Trophy

**SKINS GAME (Voluntary)**  
**\$5 Gross Skins & \$5 Net Skins**  
**Flighted at each event.**
