



# 2026 SOLO 100 RULES

## Single 100 Bass Tour, LLC

Effective December 10<sup>th</sup> 2025

Call 706-972-0108 for Registration

**Entry Fee: \$3000 – this includes all 4 tournaments**

**Full Field: 100 Boats**

The Solo 100 Bass Tour is a SOLO trail, all anglers will fish alone and cannot have any person in the boat with them.

Registration opens at 8am central time on December 10<sup>th</sup>, 2025

The following rules apply to all top 100 Solo series operated by Solo100 during the 2026 season. These rules can be changed by Solo 100 at any time upon notification to its members, which will be published on the S100 website solo100basstour.com. Interpretation and enforcement of these rules will be left exclusively to the tournament director.

1. RULES VIOLATION: In the event of a rule violation, S100 may impose such sanctions as deemed appropriate, including, without limitation, loss of one or more fish in question, loss of the catch of the day, disqualification from the event, forfeiture of prizes and/or entry fee, probation for up to 6 months and prohibition from participation in subsequent tournaments. The decision of S100 shall be final in all matters.

Each competitor agrees to report any violation or infraction of any tournament rules to the Director. Failure to report violations, self-report violations, false reporting, or suggestions to another competitor of an unreported violation of these rules will be cause for disqualification. All serious rule violations must be reported to the tournament director immediately, no matter whether it is a self-reporting violation or another contestant's violation. All others must be submitted on-site in writing within 15 minutes after the announcement, "The scales are closed".

1. Penalties may include the following:
  - A) Loss of one or more fish in question.
  - B) Loss of catch of the day.
  - C) Disqualification from the tournament in question
  - D) Disqualification from future events
  - E) Any different or additional penalties determined by the tournament director, Including but not limited to monetary forfeiture, probation, and/or loss of S100 year points.

## 2. ELIGIBILITY AND PARTICIPATION

2.1 18 years of age or older. Proof of age to the satisfaction of tournament officials is the responsibility of the potential competitor. S100 may, at any time, decline to accept tournaments entries for any reason.

2.2 A properly filled out, and signed liability release must be presented by the angler to SOLO100

or Rules Committee on or before the first event fished for the season.

2.3 Competition days, competitors are required to have documented proof of a minimum of \$100,000 boating liability insurance covering the boat being

used. A copy of proof of insurance must be with the boat being used and must cover the competitors using that boat. Random checks will be conducted at tournament registration and/or tournament weigh-in. Any competitor not in compliance will be disqualified.

### 3. REGISTRATION

EVENT/PACKAGE ENTRY FEE: \$3000 covers all 4 tournaments, including championship.

3.1 Priority Registration: Beginning at 8:00 am CST on December 10<sup>th</sup>, 2025, is reserved for entries from solo100 members who fished for the 2024 season in their respective tour and by paying for all four events within a division of \$3000 total or \$1000 December 10<sup>th</sup> and the balance due by Feb., 20262026

3.2 Package Entry: Beginning at 8:00 am CST on Dec 10<sup>th</sup>, 2025, may begin registering for package entries by paying for all 3 events plus championship events within a division of \$3000.00 total.

### 4. MEDIA COMMENTS, PUBLIC ATTACKS

The favorable public reputation of SOLO100 as a sanctioning organization in the sport of fishing, its officials' integrity, and the reputation of its media properties are valuable assets and tangible benefits for solo100. Accordingly, it is an obligation of competitors to refrain from comments to the news media that unreasonably attack or disparage the integrity of tournaments, tournament officials, sponsors, fellow members, fellow anglers, or the solo100 organization. Competitors are encouraged to express themselves and have the right to question rules officials. Responsible expressions of legitimate disagreement with solo100 policies are encouraged as opposed to attacks upon the integrity of the rules or officials. However, public comments that a solo100 knows, or should reasonably know, will harm the reputation of solo100, solo100 officials, or sponsors shall be considered conduct unbecoming a professional and will result in disciplinary action.

### 5. OFF-LIMITS/PRACTICE

5.1 Off-Limits: There are no off-limits or practice periods for divisional qualifying events.

## 6. ASSISTANCE:

6.1 Contestants may not receive assistance from anyone other than another contestant for the purpose of locating or catching fish during competition.

6.2 Beginning Monday and continuing through Thursday 5pm the week of the event, solo100 are prohibited from fishing with anyone who has acted as a guide on the tournament waters within the past 30 days.

6.3 Buying or bartering for fishing locations, including purchasing GPS locations from other than publicly available OEM commercial mapping, is prohibited.

6.4 Competitors may not use any type of Drone, "SKIN DIVE" or "SCUBA DIVE" in the tournament waters.

6.5 Contestants are not allowed on tournament waters after 3 PM on Thursday prior to the event. Sign-ups will be from 3pm-5pm immediately following a pretournament meeting at 5pm. The only exception is for boat repairs/testing, and the tournament director must be contacted and consent to any related activities.

## 7 COMMUNICATIONS:

7.1 Communication: During official competition day(s), a competitor may not use a C.B. radio, a VHF marine-band radio, a cellular phone, texting, or any other type of communication device for the purpose of locating or catching fish. Competitors are permitted to transmit by radio or telephone only in the event of an emergency.

7.2 During official competition days, competitors can use smart devices to check weather conditions, dam power generation, tidal changes, etc. Smart devices may not be used for locating fish through messaging, social media, blogs, photos, or videos.

7.3 Tournament officials must be granted access to the competitor's boat and cell phone at any time during the competition through the conclusion of activities.

## 8 HOLE SITTING/OBSTRUCTION

8.1 Hole Sitting: The practice of “hole-sitting” is strictly prohibited in all events. Competitors may not follow non-competitors’ boats for the purpose of a non-competitor assisting in locating fish.

8.2 Contestants may not block or obstruct fishing locations in any manner.

## 9 TRUTH VERIFICATION

9.1 Truth Verification: All events are subject to a truth verification/polygraph examination, and all anglers must be willing to submit to the truth verification testing. Each competitor agrees to submit a truth verification examination method as determined by solo100 and abide by its conclusion. If a competitor refuses to take or fails to pass the examination, will be disqualified from the event in question, all future events, and other additional disciplinary actions deemed appropriate.

**10 OBSERVERS:** Solo100 reserves the right to assign an observer to any competitor’s boat at any time. Refusal to accept a solo100 assigned observer will result in disqualification.

## 11. On-Site Check-In:

11.1 Each solo100 must check-in in person at the designated place during official onsite registration which is held between the hours 3pm to 5pm local time the afternoon prior to the first day of the event. (Event information is provided online) Failure to sign in onsite will result in disqualification, forfeit of entry fee and removal from the event.

11.2 All competitors must attend the Safety and Rules meeting, held either the evening before the event or in the water in a safe light on the first day. If the meeting is on the water, all anglers must be in their boats, ready to go.

11.3 Launch position: Launch positions will be determined by computer drawing and texted after onsite check-in is completed.

## 12. SAFETY:

Safety is paramount, and anglers must recognize that; fishing from an open boat is inherently dangerous; and as a result, Solo 100 Bass Tour seek to limit those hazards with reasonable safety rules.

12.1 Competitors must always observe safe boating conduct and speed limits. From morning boat check to afternoon check-in, competitors must wear a U.S. Coast Guard-approved chest-type life preserver, which must always be worn correctly and must have a kill switch attached while the combustion engine is in gear. This life preserver must also be strapped, snapped, or zippered securely and maintained in that condition until the combustion engine is no longer in gear. Violation of this rule shall be a reason for disqualification. "Fanny Pack" preservers are not allowed. In the event a boat is being towed, all anglers in the towed boat must wear a U.S. Coast Guard-approved chest-type life preserver.

12.2 Rules Committee may delay, shorten, restrict tournament waters, or cancel the start of an official tournament day because of bad weather or other factors that would endanger the safety of the competitors.

12.3 SOLO100 reserves the right to impose boat speed limits during any or all tournaments. The decision to impose a speed limit, the area covered by the speed limit, and/or the actual speed limit shall be left exclusively to the Rules Committee.

12.4 In the event of an emergency, competitors should call 911 immediately and then immediately notify the tournament director. Competitors may not leave the boat except to seek safe shelter in bad weather when danger may be imminent or emergency in the woods. At which time must all fishing cease.

### 13. SPORTSMANSHIP/CODE OF CONDUCT:

13.1 Anglers participating in SOLO100-sanctioned events shall observe this code of conduct and the applicable rules for the specific event in which an angler is participating. Anglers shall always conduct themselves in a manner becoming SOLO100 anglers, and their actions will not reflect unfavorably on the sport of bass fishing, SOLO100, its members, officers or representatives, tournaments, or sponsors. To this end, anglers shall use their best efforts to demonstrate professionalism and integrity in support of the sport of bass fishing. Any angler violating any of the Angler Code of Conduct provisions will be subject to fines, forfeiture of tournament winnings, probation, suspension from competing in SOLO100-sanctioned events, permanent ban from competition, or any combination deemed appropriate by SOLO100. Competitors are expected to follow high standards of sportsmanship, courtesy, safety, and conservation.

13.2 Harassment of competitors or non-competitors of any kind during any Practice or Event will not be tolerated and will result in immediate sanctions or

rejection of entry. Any competitor banned or refused entry from another organization will not be permitted to enter any solo100 events and such refusal will be in force until the organization lifts the restriction.

13.3 Any competitor's use, possession, or consumption of illegal drugs during tournament hours, or pre and post-tournament activities will cause automatic disqualification from this and all future tournaments. (Exception: medication prescribed to the angler by a licensed physician). The consumption of alcohol during tournament hours is prohibited. Tournament hours are defined as check-out in the morning through the competition of weighing the fish in the afternoon & final awards.

13.4 Chemical substance addiction or abuse, crimes involving moral turpitude, the conviction of a felony not specifically exempted by SOLO100, or other conduct reflecting unfavorably upon efforts to promote safety, sportsmanship, fair competition, and compliance with tournament rules shall be grounds for rejecting any application for participation and/or for disqualification. Any disqualification, suspension from, or disciplinary action imposed by any fishing organization will be grounds for rejecting applications for participation in a tournament and/or disqualification from a tournament after circumstances are reviewed by the rules committee.

13.5 Maximum courtesy must always be practiced, especially when boating and angling near non-competitors. Any act of a competitor which reflects unfavorably upon efforts to promote water safety, fisheries conservation, clean waters, and courtesy will be a reason for disqualification.

#### 14 FEDERAL AND STATE REQUIREMENTS

14.1 All competitors are bound by the prevailing statutes and regulations of the federal government and state where the tournament is being held, and all participants must have the appropriate state fishing license.

15 TACKLE AND EQUIPMENT: The use of a landing net is allowed. The use of grippers in landing bass is prohibited. Only artificial lures may be used. No "live bait" or "prepared bait" except for pork strips or rinds. Only one casting, spin casting, or spinning rod (8-foot maximum length from the butt of the handle to rod tip) and reel may be used at any one time. All bass must be caught alive and in a conventional sporting manner. When visually fishing for bedding bass, bass must be



hooked inside the mouth. While bed fishing, any fish hooked outside the mouth are to be immediately released and not counted in the day's catch.

16 HORSEPOWER REGULATIONS: Maximum horsepower for all outboard motorboats used in tournament competition will be 250 HP. Horsepower cannot exceed the limitations set by the U.S. Coast Guard, the manufacturer's rating plate, or the maximum horsepower set by SOLO100. In the event there is reason to suspect the horsepower requirement is exceeded, the competitor agrees to submit their boat and outboard motor used in the tournament to an inspection by factory-trained personnel. Changing or altering standard factory parts of a competitor's engine to increase the horsepower over the factory horsepower rating is forbidden and will result in disqualification.

#### 17 BOAT, MOTOR, AND EQUIPMENT:

17.1 Every boat must have all required U.S. Coast Guard safety equipment during competition.

17.2 During competition, all boats must have an operational and approved ignition kill switch and a single lanyard. The lanyard must be attached to the driver's body any time the combustion engine is in gear, and the driver must be in the driver's seat in full control of the boat.

17.3 All boats must have a properly aerated live-well capable of sustaining a limit of fish. Determination of acceptable and properly aerated live-well will be left exclusively to the Rules Committee.

17.4 Any raised platforms or decks cannot be higher than the gunnels of the boat. Fishing while standing on the outboard motor or boat seats is not allowed.

17.5 An electric trolling motor may be used for slow maneuvering; however, trolling as a method of fishing is prohibited.

17.6 All bladder tanks and any other type of auxiliary gas tanks that are not installed by the boat manufacturer are prohibited. Boats that do not have factory-installed gas tanks are restricted to a maximum of 18 gallons of gasoline in tanks, properly secured or strapped, and meet U.S. Coast Guard regulations. No portable gas tanks or containers capable of holding gasoline can be placed anywhere on tournament waters or shorelines for use by any tournament competitor.



17.7 No “barges” or similar craft or “stick steering boats are permitted. Fishing boats less than 16 feet in length may not be used. Determination of acceptable fishing boats (NO JET BOATS) will be left exclusively to the Rules Committee.

18. BOAT INSPECTION: The Boat inspection before blasting off by video.

19. PERMITTED FISHING LOCATIONS:

19.1 The Tournament Director may establish tournament waters and off-limits areas for each tournament. Specifically, any water within tournament waters posted “Off-Limits” or “No Fishing” by state or federal agencies will be OFF-LIMITS and announced at the Tournament Briefing.

19.2 Only water open to all public fishing and accessible by boat on the tournament waters will be considered tournament waters.

19.3 All angling must be done from the boat.

20. COMPETITORS MUST REMAIN IN BOAT:

20.1 Competitors must leave and return to the official checkpoints by boat.

20.2 Anglers cannot leave their boat to land fish or make the boat more accessible to fishing waters.

20.3 Boats must remain in tournament waters during tournament hours.

21. OFFICIAL CHECKPOINT:

21.1 There will be only one “official point” for check-out in the morning and check-in in the afternoon and will be designated at the tournament briefing.

21.2 At check-out time, all boats must fully conform to all rules set forth by SOLO Bass Tour.

21.3 At check-in, all anglers shall identify themselves by the Boat Number provided, and all fishing must cease & be at designated ramp at flight time.

22. SCORING: Tournament standings, auxiliary awards, and final winners shall be determined by the pounds-and-hundredths weight of each competitor's catch during the tournament competition days.

22.1 Only Largemouth, Smallmouth, Spotted, or Redeye bass will be weighed.

22.2 The creel limit shall be five (5) bass of the above species and varieties per day unless otherwise established by the tournament director. The official length for bass shall be established by State regulations or by the Rules Committee.

22.3 Once a tournament limit is reached and is in possession, contestants must cull immediately following their next catch, and culling of dead fish is strictly prohibited. In possession is stored in the contestant's live well, and the contestant resumes fishing or moving from the current location. If the contestant is over the possession limit, the Rules Committee will first reduce the catch to the correct limit starting with the largest fish first and assess a 1-pound penalty per fish over possession. Only bass measuring the official length or more, as determined by the longest straight-line measurement, will be eligible for weighing. Short fish will incur a penalty of 1 pound and will not be weighed. Bass that appear to be mangled, mashed, mauled, or otherwise altered will be weighed solely at the discretion of tournament officials.

22.4 Once a competitor's catch is verified by tournament officials, no additional fish may be added to the catch. Placing bass on a stringer is prohibited; however, culling tags with non-piercing clips may be used.

22.5 In the event of a mechanical failure (boat is inoperable), anglers may have their catch counted by one of the following methods ONLY:

Method 1: The Boat is towed to the weigh-in site by another boat.

Method 2: The Boater secures his boat to an object (pier/bank) and boards another tournament competitor's boat only for a ride to weigh in.

Using either method, the tournament angler must notify tournament staff of the breakdown for instructions.

22.6 Competitors must not allow any bass caught by them to be counted on the score of another competitor.

22.7 Mechanical failures do not extend established weigh-in times.

23. CATCH AND RELEASE: CULLING OF DEAD BASS IS PROHIBITED: A penalty of one .25 pounds per dead fish will be assessed and deducted from the day's total weight. In the event the angler's big fish is dead, a penalty of .25 pounds will be deducted from the big fish's total weight. The Rules Committee will have sole authority for assessing dead fish penalties. For fish care, SOLO100 recommends only the use of T-H Marine G-JUICE live well treatment and G-Force Conservation Cull System with clips that do not puncture. If you do not deflate your fish it will be penalized as a dead fish .25pounds, no more than 3.

24. LATE PENALTY: Competitors who are not in the official checkpoint area as described in Rule 21 at the appointed time shall be penalized at the rate of one (1) pound each minute. Any late penalty will be deducted from the total weight of their catch that day, including any weight to be counted toward a "big bass award." No weight will be awarded if the net weight after penalties is zero or less. Any competitor who is more than 15 minutes late will lose all credit for that day's catch. The exact starting and check-in times will be announced at the Tournament Briefing.

25. POINTS SYSTEM AND QUALIFICATIONS: Points will be awarded based on the place of finish and cannot be combined or transferred. Any angler disqualified from an event will not receive points for that event.

25.1 Divisional Events – These events are worth 100 points to first-place anglers. Points will be awarded in 1-point decreasing increments. Contestants who are not weighing fish will receive last number of the start of zeros.

25.4 Angler of the Year – Each division will have an Angler of the Year (AOY) which will be determined by the total points accrued by anglers who have fished all events within a division. There will be 5 awards for anglers of the year

25.5 Advancement – The top 30 (based on full field) point holders will earn a slot in the Championship, provided the anglers have fished all three of their divisional events.

25.8 TIEBREAKERS: Ties will be broken using the following criteria:

- a) The largest number of legal fish weighed.
- b) The largest number of legal live fish weighed.
- c) Most Accumulative weight for the year

d) If the tie is not broken by applying the preceding procedures, place monies will be split evenly, and place points will be awarded accordingly. Event winners' tiebreakers may result in a fish-off.

26. SOLO100 MEMBERS SHIELD & LOGO: SOLO100 encourages (not mandatory) the wearing of the SOLO100 Logo and Top 100 Solo logo. The suggested placement for the SOLO100 logo is centered on the left chest, the top of the patch should hit the top center of the left collarbone.

27. PATCHES AND/OR SIGNAGE: SOLO100 encourages the use of patches, logos, and other signage to promote the angler's sponsors. SOLO100 may, however, restrict the use of patches, logos, signage, etc., that promote or advertise products that are in competition with the products or services of official tour sponsors, or which are, in SOLO100 sole judgment, in poor taste. In addition, if SOLO100 provides any ancillary clothing or products (such as life vests) bearing the logos of SOLO100 or the official sponsors of SOLO100, each competitor shall wear such clothing or utilize such products in a manner prescribed by SOLO100 shirts with sleeves.

28. AWARDS: All anglers must execute a Fed Tax Form W9 before receiving any awards, including cash/check and prizes.

29. TAXES: Where and when state laws require, income tax may be automatically deducted before any awards are presented. Anglers are responsible for all applicable taxes for both cash and merchandise awards.

30. WAIVER AND RELEASE: As a condition of participation in each tournament, competitors must execute a waiver (Release of Liability and Assumption of Risk) and a name and likeness release.

1. The risk of injury, disability, death, loss or damage to person or property from the activities involved in the tournament(s) is significant, including the potential for permanent paralysis, illness, injury and death to a person and destruction of equipment, and while compliance with SOLO100 rules, correct use of equipment, and personal discipline may reduce this risk, such risk does exist. In addition, the risk of illness from communicable diseases do exist (EX: MRSA, influenza, and COVID-19) from the activities involved in bass tournament and are significant and potentially life threatening and I KNOWELING AND FREELY ASSUME ALL SUCH RISK, both known and unknown.

2. If I am using my own boat in the tournament(s), I certify that I now have or will obtain prior to the tournament series, Boat Owners Liability Insurance (including coverage for third party property damage and bodily injury) with no Tournament Exclusion, having a minimum limit of at least \$100,000.00 Liability per occurrence and I will provide satisfactory evidence of having such current insurance to any SOLO100 official upon their request.

3. I have been advised by SOLO100 of the contents of this document through my reading and have had the opportunity to seek legal counsel with respect to the legal effect of this document prior to signing it through.

4. I KNOWINGLY AND FREELY ASSUME ALL RISKS REFERRED TO ABOVE, AND ALL OTHER RISKS OF TOURNAMENT PARTICIPATION, BOTH KNOWN AND UNKNOWN, EVEN, WITHOUT LIMITATION, IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES (AS DEFINED BELOW) OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION IN THE TOURNAMENT (S:)

5. I willingly agree to comply with the terms and conditions for participation in any tournament of SOLO100 and should I observe any unusual hazard(s) in my presence or during participation which could potentially cause injury or damage to any person, I will remove myself from participation and bring such hazard(s), to the attention of

I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNEES, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS AMERICAN BASS ANGLERS, INC., ITS PARENT AND AFFILIATED COMPANIES, THE OFFICERS, OFFICIALS, DIRECTORS, SHAREHOLDERS, AGENTS, CONSULTANTS, AND/OR EMPLOYEES OF EACH, OTHER PARTICIPANTS, AND SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND, IF APPLICABLE, OWNERS AND LESSORS OF PREMISES AND PROPERTY USED TO CONDUCT THE EVENT ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHICH I SUFFER OR WHICH I AM FOUND TO HAVE CAUSED IN WHOLE OR IN PART BY MY NEGLIGENCE OR INTENTIONAL MISCONDUCT, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES, OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

7. If there are any questions raised by the judges or officials of Solo100 as to my veracity in respect to my participation in any tournament, I agree to submit to a polygraph examination and understand that failure to pass the examination will result in disqualification from such tournament and potentially from Solo100 at its discretion as provided by the rules of the organization. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT AND THE ATTACHED RULES, AND I FULLY UNDERSTAND THEIR TERMS, I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY.



8. Each boat must have a camera that you can blast off at any ramp. You must record live well check & blast of time. Everyone will have to check in and ramp location. Weigh in on time if you go to ramp with trailer, you will have to go through live well check as you are taking out by camera and must be at weigh in on time. This is a trail from start & will change if needed by Rules Committee

9. PUBLICITY.
