X. REPORTS OF TRUSTEES AND ACTION ITEMS

A. Public Safety – Pete Connolly

Chief Roberts reported the following: 1) The Village was mostly spared during the recent windstorms; Kane County had more damage than DuPage. 2) Bartlett & St. Charles have had an uptick in burglaries but nothing in Wayne. 3) On March 5 No Parking/Authorized Vehicles signs were posted by DuPage Forest Preserve at Army Trail east of Powis. The Police Dept. cannot enforce tickets on another jurisdiction. Parking is not allowed in the grass; police are issuing warnings.

C. Public Works – Mike Dimitroff

Trustee Dimitroff reported: 1) PW has done end-of-winter litter clean-up on Army Trail, Powis, Munger and Smith Roads. Next step will be clean-up west of Dunham. 2) Public Works has repaired potholes. 3) Tree trimming and shoulder gravel will be done soon.

E. Development/Historic and Rural Preservation – Ed Hull

Trustee Hull discussed Robin Lane and residents' inquiry of who owns the road. This issue pops up every couple of years. When it was first annexed, the developer's plan mistakenly listed it as a public road, but Village paperwork/plats show it as a private road. Further, prior Village Boards took action concerning the annexation to affirmatively declare that Robin Lane is a private road and to make it clear that the Village did not accept Robin Lane as a public road when the area was annexed. As Robin Lane needs repair, he will again suggest the neighbors create an SSA to maintain the road. In other matters, DuPage Forest Preserve is still thinking about ways to camouflage the outhouse west of the depot, looking for Eagle Scout projects, etc.

H. Technology – Guy Bevente

Trustee Bevente said 1) Phase I of infrastructure project is complete. Phase II is tied to long-term solutions for the Police Dept. 2) He had a meeting with Lumos and our village attorney Pete Wilson to discuss legal side requirements regarding license, franchise, permitting to gain access to Village right-of-way. Eng. Lynch meets with Lumos this week to discuss construction engineering plans. 3) The website has been cleaned up of redundancies and the remaining work on content is underway. Discussion on AT&T, Comcast, and Lumos expected product offering and rack rates based on preliminary information was held.
