#### I. CALL TO ORDER/ROLL CALL

# II. APPROVAL OF PROCEEDINGS AND MINUTES - April 1, 2024

A Motion to approve the Additional Minutes for October 2, 2023, and the Minutes of April 1, 2024, meeting was made by Commissioner Iozzo and seconded by Commissioner Kohl. There was a discussion of amendments to the Minutes of the April 1, 2024, meeting. Thereafter, the Motion as to the April 1, 2024, Minutes was withdrawn. A vote was taken on the approval of the Additional Minutes for the October 2, 2023, Meeting and passed unanimously.

After further discussion, a second Motion to approve the Minutes of the April 1, 2024, meeting, as amended per the discussion, was made by Commissioner Kohl and seconded by Commission Richard. There were three proposed amendments to the Minutes:

1. Adding as also present, Attorney Catherine Lenert;

- 2. To provide Paragraph IV., 1. E. of the Minutes is amended to change "Paragraph C-1" to "Paragraph L-3"; and
- 3. That the Paragraph IV., 1. E. is also amended to change the number of days an unenclosed and unscreened vehicle may be parked is amended from "6 days" to "72 hours" to 10 days." (as opposed to from 6 days to 10 days)

The Motion to approve the Minutes of the April 1, 2024, meeting, as amended, was approved unanimously.

# IV. Board discussion and possible action on:

- 1. 10-7-4 Off Street Parking
  - A. There was a lengthy discussion as to whether or not the term "substantially screened" should be defined. Building Inspector Gricus expressed concern that enforcement may be difficult unless substantially screened was better defined. He questioned whether substantially screened would mean more than 50%; 75%; 90%; or something else. After discussion, it was decided that substantially screened would mean at least 75% year-round; with the current ordinance language of Paragraphs 1 and 2 in the definition of "Substantially Screened" pertaining to screening in front and side yards to remain the same.

It was also decided that "substantially screened" would be added to Paragraph C-1. There was also a discussion of whether or not the words "or trailer" would be added to Paragraph C-2, C-3 and L-1. The consensus of the Commission was it should be added.

Chairperson Dimitroff passed out a hand-out with proposed language for changes to Section C. The proposed language was reviewed by the Commissioners. After

discussion, the consensus was *not* to include the proposed language with the exception of "or trailer."

Concerning how to move forward with the above, it was decided that the changes would be transcribed and sent to the Commissioners to review prior to the next meeting for possible action at the June meeting.

#### 2. 10-2-2: Livestock Definitions

There will be a draft for discussion related to possible action on Section 10-2-2: Livestock Definitions. Thereafter, it is expected that a public hearing will be held.

3. 10-7-5: Animal Regulations - as relates to any Livestock Definitions

No action was taken on Section 10-7-5.

**4.** 10-8A-6 and 10-7-2: Signs

No action was taken on Section 10-8A-6 and 10-7-2 at this time.
