A. Public Safety – Pete Connolly

Chief Roberts reported the following: 1) 9/21 Ride for Autism; 2) 9/27 Cycle for Life; 3) 9/28 Blessing of the Hounds; 4) 10/1 Truck Enforcement detail. The Dept. worked with Bartlett and used its scale for overweight trucking which causes damage to the roads and endangers cyclists, walkers, and horses, writing tickets exceeding \$20,000 in fines. 5) 10/13 is National School Lunch week at Wayne Elementary School; 6) 10/26 is Trunk or Treat at Little Home Church. 7) The Dept. completed a Liquor Compliance check with the two businesses in town. Both businesses appropriately carded and declined to serve the underage individual. 8) A homeless person tried to gain entry into Wayne Elementary School. Police located the person and moved her to a shelter in a neighboring town. 9) President Phipps asked about electric bikes. Chief responded that the State is playing catch-up with laws regarding electric bikes. Currently they are to be used off sidewalks, off prairie paths and trails, and on roads. 10) Protective fencing was put in place by Trustee Dimitroff and Public Works on the abandoned lot in Westminster Crossing. Trustee Dimitroff has extra material if needed. The Board thanked him for his diligence in the matter.

Trustee Bevente reported the Village is now officially part of the state BEAD grant funding and in line for Round 4. Comcast received the award to cover the entire Village with broadband technology, providing upload and download speeds of 2 gigs (based on published state information.) Dates of the build-out have not been formally provided, but a Comcast rep disclosed that they are looking at 2026. This build-out is in addition to the Lumos/T-Mobile fiber build-out on the east end of town, and an AT&T fiber build-out from the Union Pacific Railroad tracks west to Dunham Road.
