I. CALL TO ORDER/ROLL CALL

The October 14, 2024, Meeting of the Village of Wayne Plan Commission was called to order by Chairperson, Carol Dimitroff at 7:00 pm.

II. APPROVAL OF PROCEEDINGS AND MINUTES - September 9, 2024

A Motion to approve the Minutes of September 9, 2024, meeting was made by Commissioner Richard and seconded by Commissioner Kohl. The Motion carried and the Minutes were approved unanimously.

III. PUBLIC HEARING ON REZONING FOR PROPERTY AT 35W199 ARMY TRAIL ROAD, WAYNE, ILLINOIS

Public hearing on the rezoning of the property commenced at 7:04 p.m. and was transcribed by the Court Reporter present. The Public hearing was closed at 7:35 p.m.

After the Public hearing was closed, the Plan Commission considered the application. During the discussion it was suggested that the W-3 zoning classification was more appropriate as the lot was over an acre in size. A Motion was made by Commissioner Richard to recommend approval of the Application for rezoning of the property at 35W199 Army Trail Road in the W-3 Zoning Classification, as opposed to the requested W-4 Classification, with the additional recommendation that the Applicant be allowed to choose the frontage of the property as either on Route 25 or Army Trail Road. The Motion was seconded by Commissioner Iozzo. After discussion of the various issues raised by the Application and during the presentation, a roll call vote was taken, and the Motion carried unanimously.

IV. PUBLIC COMMENT

Members of the public who were present are named as attached. Public comment by several residents, but not all who signed in on the issue of possible action on Section 10-2-2 Livestock Definitions and Section 10-7-5 Animal Regulations.

V. PLAN COMMISSION DISCUSSIONS AND POSSIBLE ACTION ON:

- 1. 10-2-2: Livestock Definitions
- 2. 10-7-5: Animal Regulations

Chairperson Dimitroff reminded the Commissioners that there were essentially 4 options that had been discussed at the many preceding meetings. They were as follows:

- (1) Do nothing leaving all ordinances as they are;
- (2) Add a defined species of goats to the current definition of livestock;
- (3) Allow a defined species of goats with certain restrictions per the proposal provided by Commissioner Tranchida, which sets forth certain goat information and proper nomenclature; a proposal for cumulative numbers of goats with horses; shelter and fencing requirements; and requirements for safety and daily needs; or
- (4) Establish an additional Special Use category listing all allowable livestock, as defined in the ordinance (with all others to be disallowed), as eligible for authorization by application, upon hearing and approval by the Village Board pursuant to the existing Special Use procedure.

A Motion was made by Commissioner Kohl that the Plan Commission recommend to the Village Board that the Ordinances relating to Livestock Definitions and Animal

Regulations remain the same and that no changes be made. The Motion was seconded by Commissioner Richard. After discussion, the Motion carried on a roll call vote of 6 to 1, with Commissioner Tranchida opposing.

VI. OTHER BUSINESS

There was a brief discussion as to whether the Plan Commission would review the Village's Comprehensive Plan for possible recommendations. The matter may be considered on future agendas.

VII. ADJOURNMENT

A Motion was made by Commissioner Richard and seconded by Commissioner Kohl to adjourn the meeting. The motion carried unanimously. The meeting was adjourned at 8:25 p.m.
