New Business A. APPLICATIONS

Restore Home

House has been uninhabited for about 10 years. There is mold and a great deal of work to be done. The new owner has completed an impressive restoration of the parsonage on

Army Trail Road. There was discussion on a long list of items to be done. Possible replacement of the garage required a site visit due to its being listed on the register as "contributing". Jim Issel and Tony Stratton volunteered to make a visit and report back on condition of building at our next meeting. Overall following is a response to the various projects in regard to approval at this meeting, additional information needed, and items not subject to approval by Historic Sites commission (indoor work).

Line Items approved:

- 1) Half round gutters and extend drains away from house
- 2) Remove two octagonal windows on east side, either side of chimney, replace with square stained glass windows
- 3) Install AC unit on West side of house, toward back of house
- 4) Repair back porch and back door
- 5) Replace overhead electrical to building with below ground electrical
- 6) Replacement of some windows like for like design with aluminum clad wood windows. Exterior trim to be maintained. Porch windows to be maintained.
- 7) Repair existing aluminum siding
- 8) Repair existing front porch door

Line items requiring sketch, plan or more information:

- a) Tear down old shed/small door entry to basement and build new basement entry including new full height door and greenhouse provide plan and pictures
- b) Garage tear down Two historic sites commissioners to inspect and report back on condition
- c) rebuild or remodeling of garage would require plans
- d) New cement driveway will require plan
- e) Repair and extend front porch to include landing will require plan

Line items not requiring approval by Historic Sites Commission, but may require building permits::

- A) Install HVAC and water heaters
- B) Install new interior electric
- C) Replace existing plumbing as needed, add water softener and charcoal filter
- D) Build interior staircase from pantry to basement
- E) Repair bathrooms including replacing claw tub with shower
- F) Replace kitchen cabinets and sink
- G) Remove mold and replace drywall in bedroom
- H) Waterproof basement or install French drains
- I) Insulate attic
- J) Repair or replace interior floors

Motion to approve items 1-8 above made by Kim Killian, seconded by Tony Stratton, approved unanimously.

B. Reports

Possible resurvey of historic district discussed. Chair to look into estimated costs and recommendations for professionals.
