Resident Frank Charamonte commented on the increase of truck and traffic noise on Route 59, affecting the quality of life in Woods of Wayne subdivision. The road is in IDOT's region, not the Village of Wayne. President Phipps will discuss with Rep. Dan Ugaste at her meeting in November.

Resident Tom Kennedy asked the status of the Billy Burns Right-of-Way. Trustee Dimitroff said it is an unimproved unused lot. President Phipps said there was nothing on tonight's agenda, so no action would be taken.

Resident Mike Pope spoke on behalf of his neighbors Lynn & Chuck Persico regarding increased traffic and noise on Route 59 and requested a sound deadening wall.

Jennifer Donatelli commented on increased truck traffic and noise on Route 59, negatively affecting quality of life and decreasing property values.

Attorney Wilson stated the Plan Commission met October 14. A Public Hearing for rezoning was held for a 1.12 acre property from a legal non-conforming W-1 zoning. The Commission voted to recommend no change to the definition of livestock or livestock regulations; Codes 10-2-2 and 10-7-5 to remain as written.
