- 6. Sublessee shall reimburse Sublessor for Sublessor's share of charges for utilities connected with the premises during the term of the sublease. Reimbursement shall be made within ten days of presentation by Sublessor of copies of the bills for such utilities to Sublessee. Portions of any month reflected on a bill shall be prorated, as necessary, based upon the number of days of occupancy by Sublessee.
- 7. Sublessee agrees to surrender and deliver to Sublessor the premises and (if any) all furniture and decorations within the premises in as good a condition as they were at the beginning of the

8. Sublessee agrees to pay to Sublessor a deposit of \$ to cover damages and cleaning. Sublessor agrees that if the premises and contents thereof are returned to Sublessor in the same condition as when received by Sublessee, reasonable wear and tear thereof excepted, (s)he will refund to Sublessee \$ at the end of the term, or within 30 days thereafter. Any reason for retaining a portion of the deposit shall be explained in writing within 30 days to Sublessee.
9. At the time of taking possession of the premises by Sublessee, Sublessor and Sublessee will sign an inventory of all personal property of Sublessor that will remain in the premises.
10. This sublease agreement incorporates and is subject to the Original Lease between Sublessor, the landlord, and others, a copy of which is attached hereto, and which is hereby referred to and incorporated as if it were set out here at length. Except for the obligation to pay rent to the landlord (which remains the Sublessor's obligation), Sublessee agrees to assume all of the obligations and responsibilities of Sublessor under the Original Lease for the duration of the sublease agreement. Sublessee understands that the premises, other than the bedroom now used by the Sublessor and to be used by Sublessee, will be shared with the other individuals who have signed the Original Lease as tenants (or their sublessees, if any), and hereby agrees to act reasonably and responsibly in sharing the premises.
11. In the event of any legal action concerning this sublease, the losing party shall pay to the prevailing party reasonable attorney's fees and court costs to be fixed by the court wherein such judgment shall be entered.
