**Church fined for COVID services: Calvary Chapel San Jose has been ordered by a judge to pay \$1.2 million in fines to the county of Santa Clara for violating its COVID pandemic rules by allowing people to gather in the building and worship maskless. According to Judge Evette Pennypacker, “It should appear clear to all — regardless of religious affiliation — that wearing a mask while worshipping” helps “protect others while still exercising your right to religious freedom.” The church’s pastor, Mike McClure, has argued the opposite, noting that many people have said that allowing people to come and worship literally saved their lives. Furthermore, multiple studies demonstrating that masking had almost no effect on preventing the spread of COVID only support McClure’s position. The church has also countersued, contending that members’ religious liberty rights were violated.**

## **Former CIA Officer Larry Johnson: This Is A Controlled Leak To Prepare The Public For "Crash Landing" Of U.S. Foreign Policy**

Former CIA officer Larry Johnson, who did presidential daily briefings during the George H.W.



Bush administration, told "Judging Freedom" host Andrew Napolitano that he thinks the latest leak of Ukraine War documents is an inside job.

About the source, he said: "I'd put it above the CIA. This is elements connected to the Director of National Intelligence... There's no way that some National Guardsman doing [temporary duty] at Fort Bragg would have access to that."

"The information was leaked for [a purpose], to prepare the U.S. public for the crash landing that's going to take place with respect to U.S. foreign policy," he said.

"The documents are real. I'm not saying the documents are fabrications, they are not. But this cover story that's been manufactured to explain how these documents came to be produced, it just falls apart... This thing is too tidy a package, this has been wrapped up nice and neatly, this is like an episode of 'Law And Order.'"

LARRY JOHNSON: This is a coordinated media strategy, this is a disinformation campaign. The documents are real. I'm not saying the documents are fabrications, they are not. But this cover story that's been manufactured to explain how these documents came to be produced, it just falls apart. It simply falls apart based on one document, which is listed as "CIA Operations Center Report: Top Secret." I worked in the CIA operations center, and I helped prepare those reports, that's an internal CIA document. No one on a U.S. military base anywhere in the world will have access to that kind of document.

ANDREW NAPOLITANO: Who or what is spreading the misinformation? Is this CIA feeding garbage to their friends in the American and British media?

LARRY JOHNSON: I'd put it above the CIA. This is elements connected to the Director of National Intelligence. That's the one place you can bring together CIA, FBI, NSA, DIA, all the key elements. They are the one place in the U.S. government where you can assemble all this material. And the way this was so neatly packaged up -- until I saw that CIA document, I was inclined to believe that this was the work of a whistleblower wanting to flag the problems about the public discrepancy about what Lloyd Austin, the Secretary of Defense, and Mark Milley, the Chairman of the Joint Chiefs of Staff, the lies they were telling in public, as opposed to the actual reality of what they were being briefed on, in top secret briefings.

ANDREW NAPOLITANO: How embarrassed is the Biden White House, the Pentagon, and Langley (CIA), over these leaks?

LARRY JOHNSON: Some are embarrassed and horrified by it, but the strategy that is underway is the information was leaked for [a purpose], to prepare the U.S. public for the crash landing that's going to take place with respect to U.S. foreign policy. The crash landing in Ukraine, in China, the fact we're already seeing elements--

ANDREW NAPOLITANO: Are you saying this was a controlled leak?

LARRY JOHNSON: Yes.

ANDREW NAPOLITANO: Done by management, not done by some Edward Snowden, Bradley Manning-type?

LARRY JOHNSON: There are some elements within management that thought this was a good idea. This shows how unprofessional and ridiculous it is, and dangerous. This information was leaked about Israel. Part of that comes from a FISA, it's got a FISA classification on it, which does necessarily mean this is Department of Justice/FBI territory. So again, there's no way that some National Guardsman doing [temporary duty] at Fort Bragg would have access to that.

And I'm not basing that on what happened to me 40 years ago... I worked in SCIFs and I still have friends who do... None of them have seen anything like this, particularly that CIA Operations Center document, or the FISA document... This thing is too tidy a package, this has been wrapped up nice and neatly, this is like an episode of "Law And Order."





## **McDaniel: RNC Fighting Left's Attempt to Destroy Election Safeguards**

The Democratic Party's hypocrisy is on full display in Arizona as they attempt to block the counting of legally cast votes in the 2022 general election.

Democrats claim they are the defenders of the disenfranchised.

Yet they're fighting GOP efforts to protect voters from being further victimized by shoddy election management during Arizona's 2022 midterm elections.

The Republican National Committee (RNC) is fully invested in working with Arizona Republican and Attorney General candidate Abe Hamadeh to fight this injustice. Make no mistake, the closest statewide race in Arizona history is not over yet. A review of a state-mandated recount of the attorney general's race showed that Abe's challenger, Kris Mayes, finished a mere 280 votes ahead of him out of 2.5 million votes cast, down from a lead of 511 in the original count.

During that process, Abe and our legal team discovered that Gov. Katie Hobbs (then secretary of state) withheld information that ballots were being incorrectly tabulated in one county.

That is information we believe would have compelled the judge to rule in Abe's favor and order further review of the election to ensure every legal vote was properly counted, including not only the machine tabulator errors, but also thousands of provisional ballots — far more than the current margin — that we believe were improperly discarded. And so we're asking for a new trial to judicially review the relevant evidence. Hobbs, Mayes (and new) Secretary of State Adrian Fontes, want to shut the courthouse door on Abe and the over 1.25 million Arizonans who voted for him. That's why the RNC has been in the fight with Arizona attorney general candidate Abe Hamadeh from day one. Abe's motion for a new trial in the lawsuit is not only necessary but vital if we are to protect the Republic, democracy, and the men and women who fought



for our right to vote.

We believe that every qualified voter must be allowed to vote and that every legal vote must be counted.

The RNC's actions speak louder than the Democrats' hollow words.

The far-left, which works around the clock to destroy basic election safeguards under the guise of fighting non-existent voter suppression, is actively working to ensure that real election issues in Arizona go unaddressed.

In the meantime, the two top members of the Arizona Legislature, Senate President Warren Petersen and Speaker of the House Ben Toma, filed an amicus brief in the matter, urging the judge to grant Abe a new trial.

In their brief, the two leaders stress "the importance to all Arizonans of an accurate tabulation of every legal vote."

This is a united coalition of Republicans in Arizona and nationwide who are joining together to stand up for the rights of the disenfranchised in the Grand Canyon State. The RNC is proud to be in this fight.

This is not about overturning an election.

It's all about knowing with confidence who actually won that election by ensuring that votes have been fairly counted in the face of unusually severe election mismanagement. Shedding light on what happened in Arizona will not only result in a victory for Hamadeh, but a victory for voters across the country that will go a long way to restore confidence in our elections.



### **3 DAYS AFTER HUNTER BIDEN JOINED BURISMA BOARD, VP BIDEN PUSHED FOR FRACKING IN UKRAINE**

Former White House stenographer Mike McCormick spent six years (2011-2017) at then-Vice President Joe Biden's side as he met with world leaders, delivered speeches and interacted with members of the news media, an experience that provided him with both insider knowledge and a unique perspective.

In an interview with [The Daily Mail](#) this week, McCormick said that just three days after Hunter Biden joined Ukrainian energy company Burisma Holdings Ltd (on April 18, 2014), then-Vice President Joe Biden traveled to Ukraine to push for fracking and increased energy production.



McCormick, now an independent journalist who posts on [Substack](#), was on board the April 21, 2014 Air Force 2 flight and said that a senior Biden advisor “briefed reporters on the plane that the VP was pushing medium- and long-term strategies to boost conventional gas production, and also to begin to take advantage of the unconventional gas reserves that are in Ukraine.” The senior official’s name? Jake Sullivan, Biden’s current National Security Advisor.

So much for Biden having no knowledge of or involvement with his son’s overseas business dealings.

The Mail reported that Biden’s “push for greater energy production” was highly profitable for Burisma. “According to Burisma’s website, it ramped up production from 100 million cubic meters in 2010 to 1.3 billion cubic meters in 2018 – when it generated revenues of at least \$400 million, according to a Reuters estimate.”

McCormick said his “job was to sit in the back with journalists, with a tape recorder and microphone in case there was a statement to the press.” McCormick told the Mail, “Sullivan came to the back and did a briefing as a ‘senior administration official.’ They wanted to publicize what he said, they weren’t afraid of it. But as a senior administration official, so no name attached to it. ... He talked about what Joe was going to do with energy security for Ukraine.”

If this report is any indication, Burisma’s appointment of Hunter Biden to its board paid immediate dividends. And it is just one more story that flies in the face of President Biden’s repeated denials of involvement in his son’s overseas business dealings.
