Too much is happening, simultaneously, not to see a grand scheme leading to destruction — or, if a leftist, transformation. Reagan got it so right: "Government isn't the solution, it's the problem." He stuck to his principles, and the nation loved him for it.



Exchanging Britteny Griner for an infamous Russian Arms Dealer



Viktor Bout, a Russian arms dealer who is also known as the "Merchant of Death," will be released in exchange for the WNBA's Brittney Griner. Griner has been in a Russian prison since her arrest for illegal substances while in Russia got her handed a 9-year prison sentence just over 210 miles from Moscow.

Recently, the United States folded and decided to exchange Bout, an international arms trafficker for Giner, who has vape cartridges that were alleged to contain THC, an oil-based form of the component that achieves a high in marijuana. 2 More Secret CCP Police Stations Discovered in LA, New York: Report By Andrew Thornebrooke

A nonprofit group has discovered 48 new overseas police stations with ties to China's communist regime, including two previously unknown facilities in Los Angeles and New York City.

The newly identified sites are among more than 100 police outposts that are spread out across 53 nations.

The facilities have been used by the Chinese Communist Party (CCP) to carry out an illicit campaign of transnational repression, according to Safeguard Defenders, a nonprofit organization that published a Dec. 5 update to its findings from a previous investigation released in October. "It's outrageous that the Communist Chinese government is exercising extraterritorial law enforcement on U.S. soil," Rep. Nicole Malliotakis (R-N.Y.) told The Epoch Times in an email.

"It should be a top priority of Secretary Blinken and Attorney General Garland to shut down these stations to protect our Chinese-American constituents and our nation's sovereignty from foreign encroachment." Malliotakis was among several Republican lawmakers who issued a letter in October demanding explanations from Secretary of State Antony Blinken and Attorney General Merrick Garland for the facilities' continued existence.

Most notably, Safeguard Defenders linked the stations to the CCP's Operation Fox Hunt, a transnational scheme designed to forcibly repatriate dissidents and other targets of the regime back to mainland China to face communist persecution.

"The report describes part of the PRC's transnational repression efforts where PRC officials reach out outside their borders to harass, to surveil, to threaten individuals around the world, including in the United States, to silence those critical of its government," Price said.

Remembering Pearl Harbor

In October 1940, President Franklin D. Roosevelt declared, "I have said this before, but I shall say it again and again and again: Your boys are not going to be sent into any foreign wars." This was a reiteration of his earlier assertion, "We are keeping out of the wars that are going on in Europe and in Asia. ... Our opponents are seeking to frighten the country by telling people that the present administration is deliberately ... drifting into war. You know better than that."

Roosevelt campaigned on neutrality in 1940. Roosevelt assured his constituents, "I give ... to the people of this country this most solemn assurance: There is no secret treaty, no secret obligation, no secret commitment, no secret understanding in any shape or form, direct or indirect, with any other government, or any other nation in any part of the world, to involve this nation in any war."

Unfortunately, Germany's Führer Adolf Hitler and Japan's Prime Minister Hideki Tojo didn't cooperate.

On December 7, 1941, more than 350 Japanese planes attacked Pearl Harbor, Hawaii, killing 2,390 American servicemen and civilians and wounding 1,282. The attack sank or damaged eight battleships, three cruisers, three destroyers, and one minelayer, and destroyed 188 aircraft. It took four years and the full military-industrial capability of the United States to defeat Japan.

"There's a loophole that they've slipped through in the regulatory process, because most drugs require pharmacokinetic studies ... And that has not been done with the COVID-19 vaccines," says Dr. Tess Lawrie, co-founder of

the World Council for Health.

Pharmacokinetics is the study of how a drug behaves in a patient's body, how it distributes, and how long it takes to be cleared from the body. "Because they've been called vaccines ... all these manufacturers have been required to do is to show that the product they inject gives an immune reaction, gets an immune response. They have not been required to show how it distributes around the body," says Lawrie.

She argues that the COVID-19 injections are not actually vaccines, but are instead gene therapies. And they must be halted immediately, she says. Myocarditis is just the tip of the iceberg. Inflammation is actually occurring not just in the heart, but "in every organ and tissue of the body," Lawrie says. In this episode, she breaks down the alarming signals that independent researchers have found, and what people can do if they are worried about their own health or the health of their loved ones.


