## **Ben & Jerry's Co-Founder Placed Under Arrest Over Assange Protest**

Ben Cohen, co-founder of ice cream brand Ben & Jerry's, was arrested last week during a protest in favor of WikiLeaks founder Julian Assange.

The co-founder of the Vermont-based ice cream company was then seen setting fire to a sign that read, "Freedom of the Press" and said, "Freedom of the press is going up in smoke."

"There's no democracy without freedom of the press because the press is the only thing that can hold government accountable," Mr. Cohen said. "And there's no freedom of the press as long as Assange is being prosecuted."

Mr. Assange is being held at a prison in London as he awaits his extradition to the United States for allegedly violating the Espionage Act. Before that, the WikiLeaks founder was essentially detained inside the Ecuadorian Embassy in the UK for several years.

"It's outrageous. Julian Assange is nonviolent. He is presumed innocent. And yet somehow or other, he has been imprisoned in solitary confinement for four years. That is torture," Mr. Cohen said at the protest. "He revealed the truth, and for that, he is suffering and we need to do whatever we can to help him."



In a Twitter post, Mr. Cohen said that he and Ms. Evans were released from police custody hours later. "It's time for @POTUS to follow thru with his promise — Journalism is NOT a crime. #Dropthecharges and #FreeAssange," he added.

It comes as Ben & Jerry's drew controversy for making a Twitter post claiming that the United States should hand the property containing Mount Rushmore to Native American tribes, claiming that the United States exists on "stolen land." That post was made on the Fourth of July holiday, drawing significant backlash and calls for a boycott.

"The faces on Mount Rushmore are the faces of men who actively worked to destroy Indigenous cultures and ways of life, to deny Indigenous people their basic rights," the post alleged.

In response, country singer-songwriter John Rich wrote: "Make @benndjerrys Bud Light again."

The Post and Washington Examiner also called for boycotts of the ice cream brand.



“The brand backed bad-joke Occupy Wall Street, for crying out loud; it aligns with the anti-Israel BDS movement. Co-founder Ben Cohen funds groups opposed to US military aid to Ukraine,” the Post’s editorial wrote before calling for a boycott of the ice cream company. “Remember, America, you don’t have to accept woke preening from corporate elites. Speak up—with your wallets.”

It also comes as one Native American tribal chief, Don Stevens,told the Post that If Ben & Jerry’s is “sincere,” the company should hand over its Vermont properties to the Coosuk Abenaki Nation.

## **The final battle for the future of humanity**

**We must fight on to complete victory because our children need defending**

Five years ago today I was on holiday in Pervalka, Lithuania with my two daughters, their (Lithuanian) mother, and both of my parents. It is a quiet and beautiful spot, a place amenable to deeper reflection on the happenings of the

world. Summoning up all my skill at synthesis in one go, I wrote the essay "WWG1WGA: The greatest communications event in history" to paint the big picture of what I saw unfolding. By offering clarity with brevity, it resonated with the wider public, and got considerable attention on social media. This launched me into being the "British face of QAnon" — whatever that label may mean to you.

My life has never been the same since, and I have no regrets. There is no pleasure in being on the right side of history here.

This is not just a Second American Revolution (or Second Revolutionary War of Independence from European aristocracy). Nor is it even a second go at having the first one, as the initial effort was incompletely successful. Rather, it is a much greater worldwide fight over the essence of our species.

Looking back, the critical paragraph in the original essay is this one:

As I have learned more, and done the hard work of fact-checking, my own views have shifted. I once saw Trump as a loud-mouthed billionaire with a colourful history, and the probable lesser of two evils. Now I realise that I was hopelessly wrong—in his favour. I have therefore totally changed my perspective as more verifiable data sources have arrived (with Q just being one of many).

It was a tiny anomaly that got me started: if Donald Trump was an irredeemable lifelong racist, he seemed to be an utterly incompetent and unaccomplished one, which didn't fit the media narrative. So I started to ask questions and dig for data. Whether I was right or wrong about the man is not important at this point: what matters is that I am willing to adapt in the face of new information, and let go of previous beliefs.

The original essay kept me in my own comfort zone by restricting it to a geopolitical conflict of relatively conventional means constrained to the surface of Earth. Now I can see my "universe of discourse" was under-sized, and I am scrambling to take on the true scale of what we are participating in. I cannot prove all of these matters, but I now have as working hypotheses:

- This is a battle over (eternal) souls that are beyond time, and the "Biblical" nature of it is not an analogy or metaphor; it's absolutely literal.
- There is a complete hidden underground civilisation of which we are mostly unaware, which includes ancient tunnels and massive infrastructure.
- A great deal of hidden activity is going on at both polar regions, and it matters.
- There is an off-world element to this war, and I can no longer give you a certain definition of "world" either, since we have been lied to about everything.
- Teasing apart the psyops from the truth is hard when you cannot visit the poles or go to "outer" up "upper" space in person, but that we are being deliberately confused says that there is something important being hidden from us.
- We are not the only species involved (on either side).
- Activity here on Earth with scalar and nuclear weapons has attracted attention from "elsewhere" as it presents risks beyond our neighbourhood.
- We are seeing an inter-dimensional conflict that involves quantum physics and timeline engineering, as well as an "unseen realm" of consciousness (and demonic activity).
- Our history has been completely erased and edited, although you can

more or less piece it together once you accept that the timeline (from geological to geopolitical) is a complete lie.

- A cycle of civilisation resets and cataclysms has occurred, even if who or what is causing the resets remains unclear. But we are easily manipulated into catastrophic wars and cultural self-destruction, over and over.
- The conflict occurs as a base level of consciousness, and we are subverted in our ability to engage in the war by our restricted and modified language (and lack of understanding of symbolism, gematria, and numerology).
- Genetic engineering is a major part of this conflict, and humans are likely the result of external intervention and intelligent design, which begets the question of who designs the designer.
- We are living in the clone wars, but don't notice the clones about us.
- We as humanity have been enslaved for a considerable amount of time, being used as slave workers, sex slaves, lab rats, organ donors, blood hormones sources, and even food. The battle for freedom is much more than just legal and debt slavery, or human trafficking — and is much darker.
- The truth is widely available in the media for those with eyes to see and ears to hear, but is presented as fiction, and is often too weird to internalise as being possibly disclosure or documentary.
- We have been living in a scripted reality with an unseen class of controllers. Events are “predicted” decades ahead because they are engineered.
- There are astronomical objects and/or cosmic technologies that are affecting our consciousness, and ability to physically participate in a wider galactic civilisation. We're fenced-in, somehow, and our superpowers of perception are turned off.
- Parasites and parasitism are essential to understanding how energy is captured and harvested between species. There is an important divide between the primary drive for nurture, and the secondary entities that live off it. It is as much a parasite purge as a war.
- The war is primarily fought using technologies that we cannot perceive: EMFs, corrupted food, poisoned water, nanotech, darkened skies, AI, synthetic biology. The propaganda element is important, but not enough to explain the level of control over human minds.
- Transgenderism is a stepping stone to transhumanism, which then leads to post-humanism. Consciousness is completely disembodied and de-incarnated, as if it were some “AI borg in the sky”. The battle is ultimately the mechanics of procreative organic life versus a technological sex and death cult.

It doesn't matter to me in the slightest at this point whether I get mocked for holding these ideas as possible or likely, since the mockers are self-evidently fools, ignoramuses, and cowards. Your opinions are valueless to me, and casual denigration only works to discredit you. Yes, I may have to adjust my understanding over and over again, but at least I am learning and growing, and that is what matters. I have a “pole star” of where truth intersects with righteousness, and all I have to do is clear my vision of that point and follow it unwaveringly.

## Silencing the 'Sound of Freedom'

Why is the leftist media targeting a movie about child sex trafficking?

Arguably no issue is less partisan, and more likely to unite people of every political stripe, even in our current state of hyper-polarization, than child trafficking. How could opposition to the cruel kidnapping of children and their forced recruitment into the international sex trade fail to draw unified support from all corners? And yet when a movie comes along that dares to address this uncomfortable topic, this horrific evil, head-on – a movie aimed not only at raising awareness but at inspiring action – the Left curiously rallies to undermine it with partisan smears and ugly innuendo.

Angel Studios' *Sound of Freedom* opened last week, a thriller based on the captivating true story of Tim Ballard, a Homeland Security Special Agent frustrated by the lack of effective rescue strategies and prosecutorial authority to help trafficked children in underdeveloped nations. Ballard decided to circumvent the law enforcement bureaucracy to find a more direct, if dangerous, way to undertake the rescue of missing children. In 2013 he founded Operation Underground Railroad (OUR), a U.S.-based nonprofit dedicated to saving children from sex trafficking and sexual exploitation. The organization reportedly has undertaken more than a dozen sting operations. Actor Jim Caveziel brings his passionate intensity to the portrayal of Ballard in the film.

Anyway, Rolling Stone piled on with a sneering hit piece by a keyboard coward named Miles Klee who claims, revealingly, that Caveziel and the other filmmakers have been “fomenting moral panic for years over this grossly exaggerated ‘epidemic’ of child sex-trafficking.” Klee too dismisses the movie as a “QAnon-tinged thriller” “designed to appeal to the conscience of a conspiracy-addled boomer,” and slams its “hackneyed white savior narrative” – even though the real-life Ballard is white (unlike Klee, Ballard has actually put his own life on the line to save kidnapped children – does it matter what

color he is? It does to the racist Left).

Klee concludes his hate-filled screed with a lament that instead of making movies about police brutality and climate catastrophes, “the far right turns to these sordid fantasies about godless monsters hurting children.” Try to imagine what kind of a person rolls his eyes about the very real sexual enslavement of children worldwide, a person who calls the child sex-trafficking phenomenon a “grossly exaggerated ‘epidemic.’”

“Grossly exaggerated”? Here are a few statistics from the Polaris Project, a movement to end human trafficking:

- Human trafficking is a \$150 billion-a-year criminal enterprise business worldwide
- 27% of human trafficking victims are children
- The United States is #1 in the world for sex trafficking
- More than 500,000 children a year go missing in the U.S. alone
- Over 500,000 online sexual predators are active each day
- As of 2021, there are 252,000 websites containing images or videos of children sexually abused

Similar information can be found on many other sites dedicated to rescuing children from this plight. And yet Rolling Stone not only wants you to dismiss Jim Caveziel and the Sound of Freedom filmmakers as conspiracy theorists so that you will shun the movie and its passionate message on behalf of trafficked children, but also to believe that child sex trafficking itself is overblown, especially compared to leftist shibboleths like the police genocide of blacks and climate change.

Remember, Rolling Stone is not a serious journalistic outlet; it’s a disgraceful, celebrity-polishing, leftwing activist rag that looks to destroy political opponents first and ask questions later, or preferably not at all. It’s a magazine that defends pedophiles and child traffickers in order to own “far right” filmmakers. Think about that.

Even before Sound of Freedom hit the big screen, the Left was whitewashing child trafficking. A year ago The Atlantic, another left-wing publication, tried to discredit conservative concerns over child trafficking with a conspiracy fear-mongering piece called “The Great (Fake) Child Sex-Trafficking Epidemic.” “Dispatches from a moral panic” was the tagline.

The Left will hurl paint on priceless works of art, block major traffic arteries, and set themselves on fire to draw attention to their climate change hysteria, but then shrug off concerns about the reality of widespread sexual exploitation of children as a “moral panic.”

The media venom spewed at Sound of Freedom is so vicious and coordinated that one can’t help but wonder: who benefits from targeting the storytellers and heroes who target real-world pedophiles and child traffickers? Pedophiles and child traffickers, that’s who.
