Robert Malley: Iran's Man in DC

There's an Iran scandal brewing in the Biden White House.

"I don't wanna get into classified information," said Biden. "But to be very blunt with you, there is no clear evidence of that."

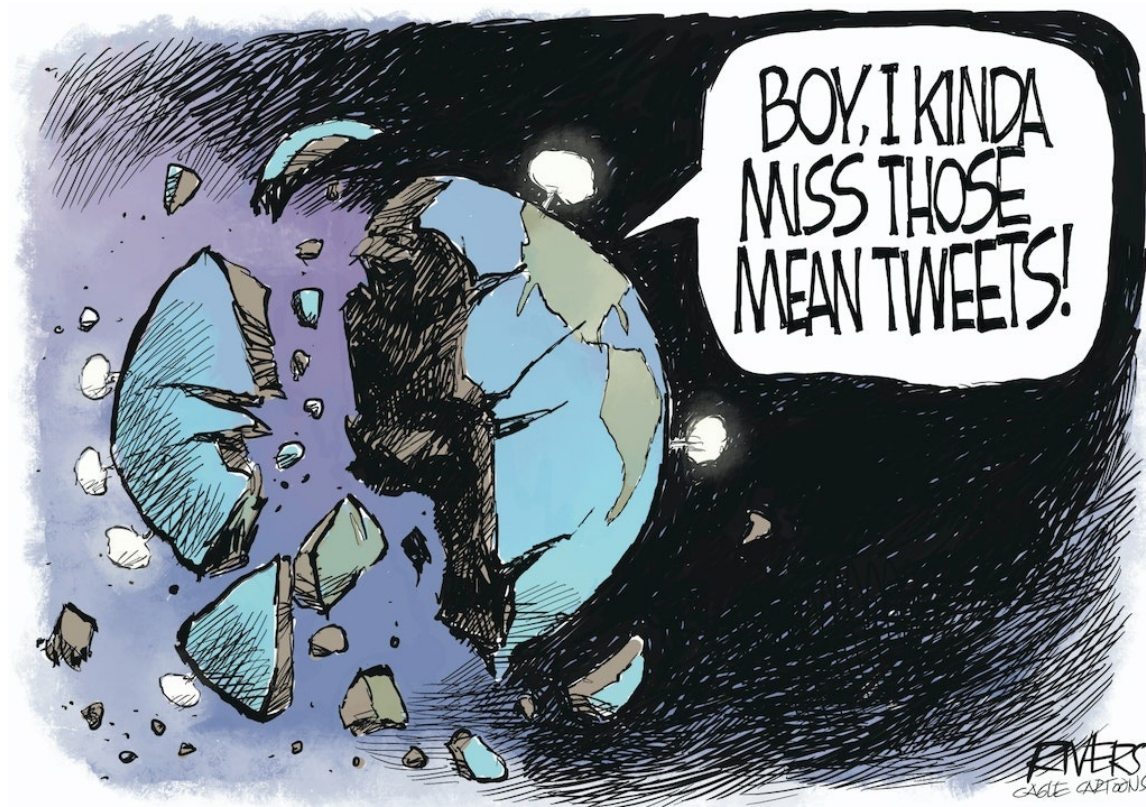

PA will pay \$2,789,430 to families of 1,500 dead Hamas terrorist murderers, this month

In addition, the PA will pay \$17,590 in salaries to 50 new Hamas prisoners, this month

Total PA monthly payment will be \$2,807,021 this month to reward Hamas terrorists for Saturday's massacre

Under Palestinian Authority law, every terrorist who is killed attacking Israel is defined as a "Martyr" whose family is immediately rewarded by the PA with a 6,000 shekels (\$1,511) grant and a 1,400 (\$353) per month allowance for life.

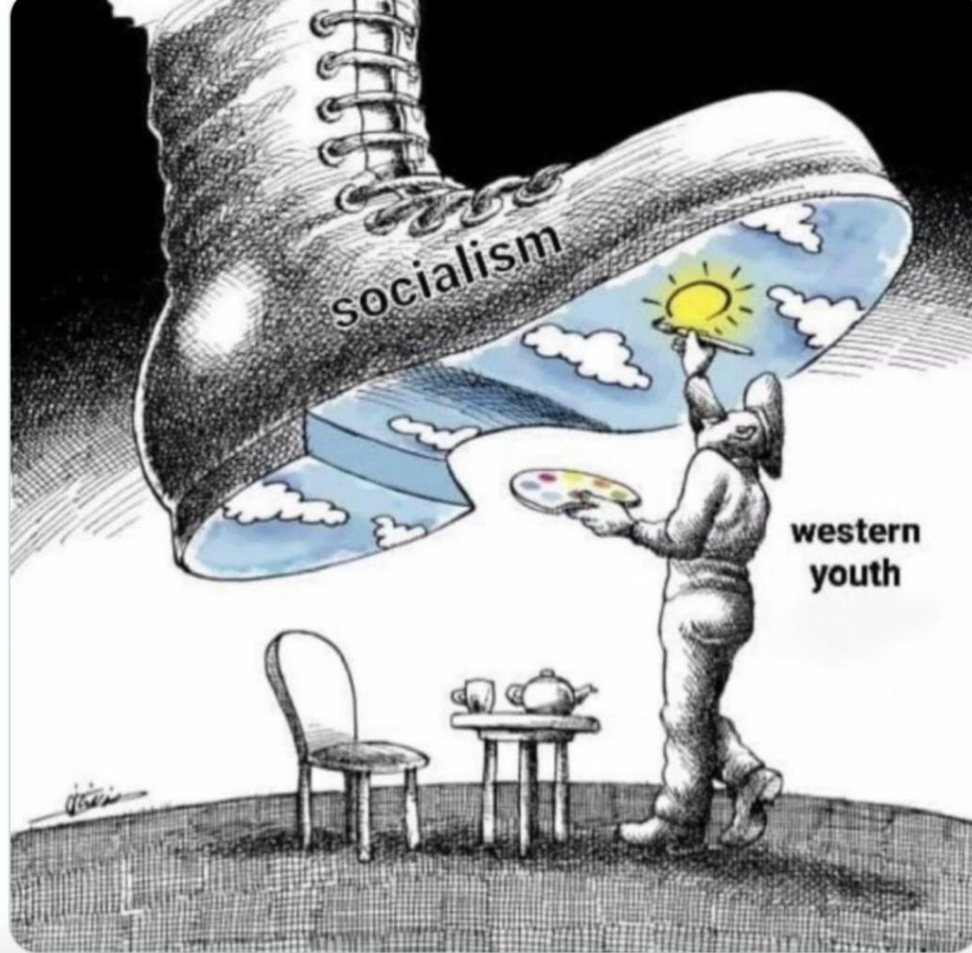
This means each family of the 1,500 dead Hamas terrorists who invaded Israel will receive 7,400 shekels for this first month. Families of those terrorists who were married and had children will receive even more. The PA will pay at least 11,100,000 shekels (\$2,789,430) this month as a reward for participating in last week's murders and atrocities against Israeli civilians.

In addition, the 50 captured Hamas terrorist murderers will receive monthly salaries in prison starting at 1,400 shekels/month which will eventually rise to 12,000 shekels/month. Terrorists who are married and have children will receive even higher salaries. This month these newly arrested terrorists will receive at least 70,000 shekels (\$17,590).

In total, the PA will pay at least 11,170,000 shekels (\$2,807,021) in payments under the PA's "Pay-for-Slay" program to the Hamas terrorists this month. This is a low estimate since as the war continues there will be additional Hamas terrorist "Martyrs" and prisoners. This figure is added to the more than 100,000,000 shekels/month the PA already pays in salaries to imprisoned terrorists and families of terrorist "Martyrs."

The Palestinian Authority should be sending a big thank you to the EU countries and Norway, currently the largest funders of the PA because the PA could not possibly make these terror payments without them. These donor countries like to pretend that it's not their money rewarding terrorists, but everyone knows that the PA could not reward terrorists without this generous foreign funding. When payments to teachers, police, and street cleaners are taken care of by international donors, the PA has the hundreds of millions available it needs to pay for terror.

U.S. Islamist Organizations Cheer on Hamas Massacre

The United States Council of Muslim Organizations (USCMO), an umbrella organization whose members include the Council on American-Islamic Relations (CAIR) and the Muslim American Society (MAS), portrayed Hamas atrocities as legitimate acts of self-defense in a statement issued on October 7, 2023. In sum, the USCMO defended an attack that represents the largest one-day slaughter of Jews since the Holocaust.

How did the United States Council of Muslim Organizations (USCMO), a prominent American Islamist organization respond when Hamas thugs beheaded captured Israeli soldiers, murdered civilians in their homes, kidnapped scores of women and children, and raped concert goers in an open field next to their murdered friends? What did it have to say about the atrocities, which represent the largest one-day slaughter of Jews since the Holocaust, which took place on Simchat Torah, the day when Jews celebrate the gift of the Torah?

None of these actions in anyway benefit the Palestinian people.

Well, USCMO issued a statement of solidarity with the Hamas thugs. It turned these atrocities into legitimate acts of self-defense. "The recent unprovoked and continuous attacks by Israel on Palestinian towns, cities, and refugee camps have resulted in tragic loss of Palestinian lives," it states.

The USCMO statement calls on governments in the Middle East to "reconsider" their decision to make peace with Israel. The USCMO also

criticizes Israel for attempting to defend itself against Hamas violence, declaring “No security measures can bring true peace in the absence of justice.”

This Tweet, posted soon after the attack, understates the number of Israelis killed by the attack, which now stands at over 1,200.

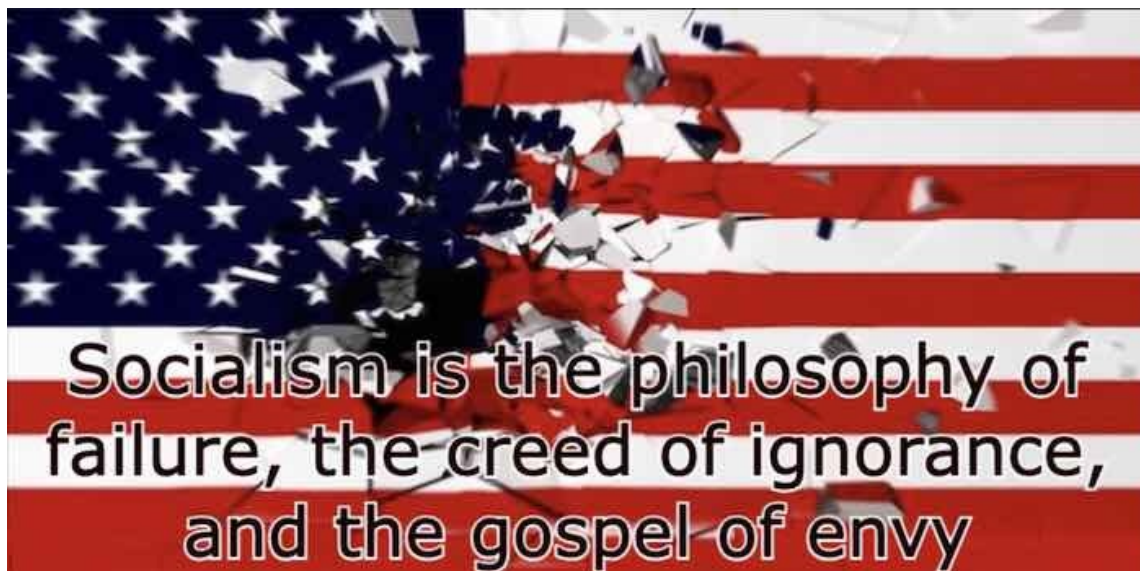
The fact that the USCMO came to the aid of Hamas really isn't a surprise. It is the largest umbrella organization of Islamist groups in America, three of which — Council on American-Islamic Relations, the American Muslims for Palestine, and the Muslim American Society — have roots in the Muslim Brotherhood. Two other member organizations, the Islamic Circle of North America and the Muslim Ummah of North America, are proxies for Jamaat-e-Islami, a violent South Asian Islamist movement that has provided funds to Hamas.

As images of Hamas barbarism continue to flood social media, the members of the organization might regret its statement. One of the most horrific videos broadcast on X, previously known as Twitter, was of the semi-nude body of Shani Louk, a tattoo artist from Germany, with a gunshot wound to her head. The video showed her being ferried, apparently unconscious, through Gaza City in the back of a pickup truck. Another video posted on X documented the abduction of another young woman, Noa Argamani, on a motorcycle as she screamed to her boyfriend for rescue. Another image posted on X showed a young Israeli boy being taunted and bullied by Palestinian children after his abduction.

The USCMO statement comes as no surprise to anyone who has been on the front lines of the fight against Islamist radicalism and jihadism in Muslim communities in the U.S., said Zuhdi Jasser, President of the American Islamic Forum for Democracy and author of A Battle for the Soul of Islam.

“If Americans ever needed a reason to completely abandon American Islamist groups wholesale as terror-sympathizing, un-American, antisemitic hate groups, the latest statement by the USCMO is it,” Jasser said. “Their comments are not fit for any faith, humanity, or justice that they claim to represent.”

The IRS routinely pulls numbers out of a hat to claim how big the tax gap is. There is no way they know this number. If they did, they would use existing resources to collect it.

The purpose of making up these numbers is to lobby for more agents — say, 87,000 — and also to pretend they can use the additional collections to pretend things like the Inflation Reduction Act are paid for.

For tax year 2020, the IRS estimates the gap to be \$601 billion. For 2021, it is estimated to be \$688 billion, which is “a significant jump” from previous estimates, according to an Oct. 12 news release. The 2021 tax gap is \$192 billion more than estimates from 2014-16 and \$138 billion more than 2017-19.

This is the first time the IRS is making tax gap projections on an annual basis. Previously, the number was published once every three years. Moving

forward, the IRS plans to publish the data yearly.

As the 2020 and 2021 tax gap numbers are estimates, they can be revised up or down at a later time.

“This increase in the tax gap underscores the importance of increased IRS compliance efforts on key areas,” said IRS Commissioner Danny Werfel. “With the help of Inflation Reduction Act funding, we are adding focus and resources to areas of compliance concern, including high-income and high-wealth individuals, partnerships, and corporations.”

If the really cared about tax cheats and high-income individuals, they would never have let the statutes expire on Hunter Biden's massive underpayments. They would also audit every suspicious activity report and every shell company to make sure all amounts were properly reported and all taxes were paid, but they didn't do any of that.

They would also audit Joe and Jill to make sure all gift taxes were properly reported and paid since they know that Hunter said he paid Joe's bills. But they didn't do that, either. It appears the Bidens are special.

How many other special tax cheats does the IRS look the other way for?

The IRS shouldn't get more agents or money until they do their job. They should also all be back in the office instead of working from home.

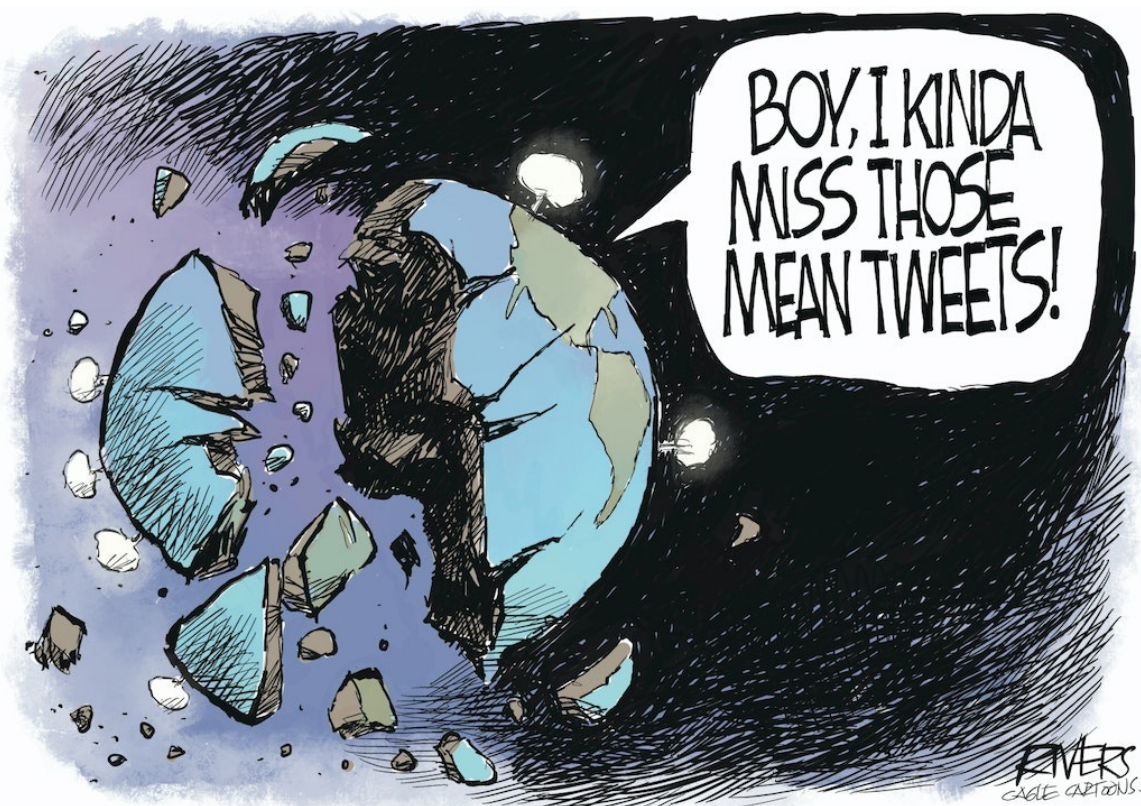

Section 1. A frequent recurrence to fundamental principles is essential to the security of individual rights and the perpetuity of free government.

Section 2. All political power is inherent in the people, and governments derive their just powers from the consent of the governed, and are established to protect and maintain individual rights.

21. Free and equal elections

Section 21. All elections shall be free and equal, and no power, civil or military, shall at any time interfere to prevent the free exercise of the right of suffrage.

32. Constitutional provisions mandatory

Section 32. The provisions of this Constitution are mandatory, unless by express words they are declared to be otherwise.

33. Reservation of rights

Section 33. The enumeration in this Constitution of certain rights shall not be construed to deny others retained by the people.
