Further it shall constitute a declaration that the horse and/or exhibitor is eligible as entered and that the owner and all of its representatives are bound by the bylaws and Rules of WHOA, the WHOA Rulebook, and the show and accept as final the decision of the Hearing Committee, or WHOA, as the case may be, on any questions arising under said bylaws and Rules, and agree to hold the show, WHOA, their officials, directors, and employees harmless for any action taken, WHOA membership required.
