From the President

On April 1, 2025, Volusia County Council voted unanimously to amend the beach code to make the dog beach in Ormond Beach permanent. This ended a 36-year ban of dogs on the beach, in this area. This was preceded by an 18-month pilot program. Daytona Dog Beach, Inc. served as "Host", providing the funding for 26 dog bag dispensers and bags, located on the beach, ramps and 2 County owned parking lots associated with this area. Our Paw Ambassador Volunteers tracked compliance during the pilot and removed trash from the area. This is a momentous and historic accomplishment, made possible by the contributions of many.

On May 5, 2025, Daytona Dog Beach, Inc. celebrated our 4-year anniversary as a nonprofit. To say that the last 4 years have been an adventure is an understatement. We have experienced ups and downs, inspiration and obstruction, exuberance and gloom, and a myriad of other emotions. But somehow, we persevered in pursuit of our mission.

This issue of "Sandy tails" serves to reflect on the dedication and hard work of our board, retracing the 4-year journey that led to an approved dog beach in Ormond. It does not nearly tell the whole story; that would require more than a newsletter.

Year 1 May 2021 - May 2022

Building Daytona Dog Beach, Inc. from the ground up was a challenging endeavor that required planning, dedication, and strategic thinking. It began with a clear mission, ensuring we addressed every issue thoroughly through research, understanding all sides of the issue. We assembled a small, and passionate, board of directors who brought various skills to the table. Legal obligations were critical, so we filed necessary paperwork to establish our organization as a legal entity with tax-exempt status. We developed our social media presence, then secured branding which we could use in marketing outreach. When Volusia County Council (VCC) voted 5-1 against allowing for a dogfriendly beach in 2021, we were undeterred. We began community outreach, building partnerships and a financial foundation. We knew we would likely have to wait until the 2022 elections brought change. Together with patience and paw-sitivity, Paula, Brenda, Nanette, with support from family and supporters moved ahead. Our Dream, Our Mission, was clear. What we found was many shared the Dream and wanted to see the Mission accomplished. One of the greatest thrills was achieving an interim goal of "Putting Paws in the Sand" in 2022. We did so through a Special Event Permit that allowed us to bring our dogs onto the beach to conduct monthly "People & Paws" Beach Clean-ups. It required a \$1M general liability insurance policy and a \$100 application fee, but it was priceless in advancing out Mission.

Year 2 May 2022 - May 2023

As we headed into our 2nd year, we continued hosting weekly Yappy Hours and monthly "People & Paws" beach clean-ups, participating in community events, sharing our Mission, sharing our petition, expanding our social media presence and raising money. We made 2 major contributions to the community in our 2nd year. First, we worked with Daytona Beach Mayor Henry and his staff to submit an application to Mars Petcare's "Better Cities for Pets" program and gained approval for Daytona Beach to be certified as a "Pet Friendly City". It was the 1st city in our County to be recognized. Ormond Beach has since also gained certification. Second, we partnered with our partner Nauti Pets to sponsor the 2023 "Bark in the Park" season with the Daytona Tortugas at Jackie Robinson Ball Park. For a small, all volunteer, community nonprofit, we were exceptionally proud of these contributions.

It's hard to gain support for a dream, especially one that had been denied multiple times over the years by the very body that controlled our destiny. No matter how hard we worked, if a majority of VCC didn't support us, we were doomed. But miraculously, people believed in our dream and provided the support we needed to keep going. For the 2nd year in a row, Latitude at Daytona Beach Foundation and their residents honored us with a \$5000 grant. 2022 elections brought new representation, an advocate, and hope that our dream could come true!

Year 3 May 2023 - May 2024

As our 3rd year began, we were actively working with Volusia County on a proposal for a dog-friendly beach to be located in Ormond Beach. Multiple interested parties weighed in and impacted the choice of location, the rules to be considered, the suggestion of a pilot program, financial and volunteer support. Finally on July 11, 2023, the vote was 6-1 in favor of an 18-month pilot program on a 0.6 mile stretch of beach in Ormond Beach. In the months ahead, we worked with Volusia County, donating the cost for 26 dog bag dispensers and bags, arranging for sponsorships and planning for the November 1, 2023 opening. We also began to formalize, train and equip our volunteer team, who voted to name themselves Paw Ambassadors. When November 1st opening day arrived, we were ready to serve as "Host" of the dog beach. Our volunteers, and their pups, began their volunteer service with pride, knowing out ultimate dream was within reach.

At the same time, Daytona Dog Beach Inc. continued to expand its reach within the community, joining our local chamber of commerce. Our sponsors and supporters rallied around us, helping to raise additional funds. We continued to contribute to the community as we had been and began new partnerships with other nonprofits in the community.

Still, we were cognizant that our Mission was still a work in progress, as there was no guarantee how the pilot would unfold and if we would receive approval for it to be made permanent. In response to expressed negativity by a small group trying to end the pilot, we launched our own petition in support of it. 18-months was a long time to wait, but we maintained our patient and paw-sitive approach, with faith in our volunteers and those visiting the dog beach.

Big Tuna Beach Bar and Grill - April 6, 2025





Our mission continues so here's to another year of endless adventures, happy People & Paws, and a beautiful, welcoming environment for everyone.






New Board Member

CHAPTER 6: THE VOTE THAT SHOOK THE SAND

The sun had barely risen when Sara pulled into the overflowing parking lot outside County Hall. Max wasn't with her this time—no dogs were allowed inside the chambers—but his face was with her, smiling from a photo she clutched tightly in her hands. Around her, other volunteers from Daytona Dog Beach, Inc. gathered, each holding their own snapshot: dogs bounding through waves, resting under umbrellas, walking calmly on leashes beside their owners. These weren't just pictures. They were proof—of joy, of responsibility, of community, and of purpose.

Inside, the air was thick with anticipation. For four long years, they had come to these meetings. Sometimes hopeful. Sometimes heartbroken. But always coming back. Today, everything hinged on this vote: Would the dog beach disappear with the tide... be extended... or, finally, be made permanent?

The chambers were full. People stood along the walls, flipping through their photos, trading stories in whispers. Sara sat near the front, her picture of Max on his back in the surf balanced on her knee. Her heart beat with a blend of nerves, exhaustion, and cautious excitement. They had done everything they could.

The public comment period came and went, but the dog beach hadn't yet been discussed. The group waited patiently, seated together, calm on the outside but buzzing with quiet tension. Each one held tightly to the photos they'd brought—reminders of the beauty and balance that had emerged from this shared dream.

A pet supply store owner talked about visitors from other counties—and even other states—who now made Ormond Beach a destination specifically because of its dog-friendly shoreline.

The numbers backed them up. The dog beach hadn't just built community—it had brought in measurable economic growth. Visitors, vacationers, and day-trippers had boosted revenue across the board.

Then Sara stood. She approached the podium slowly, Max's photo still in hand. It was her final speech—the last in a long, winding journey. She spoke not only of the beach, but of the unwavering dedication it had taken to get here. The setbacks. The "no's." The early mornings, the community cleanups, the strangers who had become friends. She thanked the council for listening, the volunteers for never giving up, and every dog whose pawprints had left something deeper than tracks in the sand.

The District 4 council member leaned forward, cleared his throat, and looked across the chamber.

"Before we vote, I want to commend this group," he said, gesturing toward the sea of photos held in proud, steady hands. "You've returned to this chamber year after year, even when the answer was no. You stayed positive. You stayed united. And through every challenge, you remained respectful—not just to this council, but to the process, the rules, and the community as a whole."

He paused, letting the weight of his words settle.

"Daytona Dog Beach, Inc. has led with professionalism—always responding to concerns with patience, responsibility, and grace.
