# **Armed Habitual Criminal Cases**

The office is committed to the prosecution of our community's most violent offenders. In Armed Habitual firearm cases, achieved an 89% success rate with an average sentence of 8.4 years in prison.

### **Child Sex Cases**

The office has a designated prosecutor dedicated to the prosecution of cases involving the physical and sexual abuse of children. These cases originate with our community's children's advocacy center – the Carrie Lynn Center. In 2023, our team maintained an above average acceptance rate and a conviction rate of 95%.

## **Juvenile Unit**

Our Juvenile Unit consists of four Assistant State's Attorneys, two administrative assistants, and one victim service provider. The unit handled over 900 new case filings in 2023.

### **Domestic Violence Unit**

The Domestic Violence Unit consists of four attorneys, two victim service providers, three administrative assistants, an investigator, and an enhanced criminal liaison. The unit executes an intentional, evidence-based prosecution strategy which from July to December resulted in an 83% success rate in felony domestic

violence cases.

### Case of Note

On October 18th, 2023, Willie Thomas was found guilty of Attempted First Degree Murder, Vehicular Invasion, Aggravated Domestic Battery, Aggravated Stalking, and Domestic Battery following a jury trial.

The morning of February 11th, 2022, a school bus driver came upon the unfolding scene of a violent attack at the intersection of N Winnebago Street and Palm Street in Rockford. A woman with blood on her face and chest lurched out of the driver's seat of a stopped vehicle as a hand from inside tried to restrain her. The woman fell out to the pavement, screaming for help, as her vehicle then drove away without her. She sought refuge on the bus and was quickly taken for emergency medical treatment. She ultimately survived her injuries and identified her attacker as her ex-boyfriend, Willie Thomas. Thomas had entered her vehicle several blocks away, after a morning of calls and texts which she did not reciprocate. They had recently broken up, and he wanted her to know he was watching her as she left her house, went to work, then ran errands. When he got in the backseat of her car, blocks from where it ultimately came to a stop and she escaped, he told her she was going to die that day.

At trial, the victim in the case testified bravely to the trauma she endured on February 11th, 2022. Prosecutors presented evidence of a timeline from that day, placing the defendant's texts to his victim in context with her whereabouts. They introduced a video from the school bus, and admitted the results of forensic testing done on the defendant's clothing when he was arrested the day of the attack. Prosecutors also presented evidence of prior domestic violence he committed against her in their relationship.

### **Deferred Prosecution-DIVERT**

DIVERT (Deferred Prosecution) is an effort to hold first time non-violent offenders accountable while avoiding conviction being entered on their record. Our office has enrolled 868 participants in the program since its inception in 2015 with 93% of those enrolled in the past year successfully completing the program.

### Mental Health Initiatives

The 17th Judicial Circuit Problem-Solving Courts provide an alternative to the traditional prosecution model for those with mental health and substance use issues as well as veterans. These courts and the newly created "Wellness Track" utilize a collaborative approach to provide participants with necessary support and resources. The programs are aimed at reducing recidivism and improving public safety.

Obtained grant from the Winnebago County
Community Mental Health Board to bring in a
specialized mental health-focused
prosecutor, dedicated to several Justice
Programs operating within the 17th Judicial
Circuit that serve individuals with mental
health, and substance use issues. This
attorney oversees the prosecution of matters
in the Winnebago County Problem-Solving
Courts and the Wellness Track.

The Wellness Track helps link individuals charged with misdemeanor offenses to community resources such as substance abuse & mental health treatment and housing assistance. Connecting these defendants and resources takes individuals out of the traditional prosecution model and allows them focus on a wellness/treatment-focused resolution for their pending criminal case.

## **Homicide Victim Memorial**

For almost 20 years, our office has hosted a service and annual reunion of families whose loved ones have fallen victim to violent crime. The Carol McFeggan Homicide Victim Memorial Service gives families and friends of the victims the ability to share memories of their loved ones and pay respects to them. The memorial aims to ease the pain of grief by bringing families together to show the community's support and remembrance of the victims. In addition to the memorial service, our office partners with Kevin Polky, CADC, LCSW, to host monthly Homicide Victim Support Group meetings.















# **Community Connections**

Our commitment to the Community remains strong. We educated hundreds of students about the role of the office in the Criminal Justice System, participated in dozens of meetings about the Pretrial Fairness Act and remained dedicated to our pursuit of justice for victims of crime. Members of our office joined the 17th Judicial Circuit Court and Public Defender's Office to participate in the annual Rockford Public School District's Academy Expo. Our booth took home the Expo's "Best in Show" award for the Service Academy.
