

## **RUBBERTITE Retarder**

### **Properties:**

*RUBBERTITE* Retarder is an additional component for three-component, water-expanding hydrogel *RUBBERTITE*.

When using *RUBBERTITE* Retarder in the ready-to-use, activated B component significantly longer reaction times can be adjusted.

### **Processing:**

The Retarder (1 kg PE bottle) is being emptied fully into a 20 l canister together with the appropriate quantity of BII component, then it is filled with water.

The quantity of water must be equal to the quantity of AI and All component (20 kg AI + 1 kg All). The mixture of water, salt and retarder is being mixed for at least 3 minutes.

BII-amounts [g] based on 20 kg *RUBBERTITE* AI-, 1 kg *RUBBERTITE* All-component and 1 kg *RUBBERTITE* Retarder.

Pot-life was tested in laboratory by using of approximately 200 g of product sample by measuring the increase of viscosity by means of a rheometer. Depending on batch and product amount pot-life may vary. That's why we recommend detecting the actual pot-life on-site before starting the injection work.

### **Safety information:**

*RUBBERTITE* Retarder is not classified as hazardous according to Regulation (EC) 1272/2008 (CLP).

Even in the case of not classified products, the standard precautionary measures applicable for chemical products should be observed.

It is therefore necessary, before beginning processing, to become familiar with the precautions and safety advice as indicated in the material safety data sheet.

**Packaging:**

1 kg plastic bottle

Bigger packaging on request.

**Storage:**

Shelf life at least 12 month in original packaging when stored in dry conditions between 15-25°C, protected from heat, frost and direct sunlight.

After the expiration the use of the product is generally not recommended, unless an approval has been provided by TPH. This approval can only be obtained by the quality assurance department of TPH releasing the material after verification of main properties being within specification.

**Disposal:**
