

## HYDROPOX EP1 LV

### Properties:

*HYDROPOX EP1 LV* is an elastic two component resin based on epoxy with special chemical and physical properties.

Due to its very low viscosity (compared to conventional EP resins) *HYDROPOX EP1 LV* is used for pore and crack filling as well as for rigidifying purposes at concrete restoration even for hair line cracks it can be used.

Because of the special material base *HYDROPOX EP1 LV* can also be used on moist concrete surfaces.

### Processing:

Mix components A and B of *HYDROPOX EP1 LV* in the prescribed proportions in a dry and clean container with the aid of a mixing device until reaching an homogeneous appearance (no streaks). Afterwards the mix is to be pumped.

Indicated injection pump: **CONTRACTOR 1U**

For cleaning of pump and injection devices we recommend the use of **PUR-O-CLEAN** (see specific Technical Data Sheet).

### Safety information:

*HYDROPOX EP1 LV* component A contains epoxy resin. *HYDROPOX EP1 LV* component B contains amines. Both components are classified as hazardous according to Regulation (EC) 1272/2008 (CLP).

It is therefore necessary, before beginning processing, to become familiar with the precautions and safety advice as indicated in the material safety data sheet.

**Storage:**

Shelf life at least 12 month in original packaging when stored in dry conditions between 15-25°C, protected from heat, frost and direct sunlight.

After the expiration the use of the product is generally not recommended, unless an approval has been provided by TPH. This approval can only be obtained by the quality assurance department of TPH releasing the material after verification of main properties being within specification.

**Disposal:**
