## **Lincoln County Library System**

Board of Trustees Meeting, March 23, 2023 1:00 p.m. – Lincoln County Library – Kemmerer, Wyoming

The meeting was called to order at 1:00 p.m. by Chairman Countryman. Present were Board of Trustees members – Anne Bluemel, Gayle Chadwick (via teleconference), Traci Countryman, Lynn Donnelley (via tele-conference), Ann Willford; Assistant Director - Missy Harris, Director – Richard Landreth.

Chairman Countryman asked if there were any changes to the agenda or to the minutes of February 16, 2023. Ann requested Public Comment and Discussion Item 5c be moved to the top of the Agenda. Gayle seconded. There were no other changes. The amended agenda and minutes were accepted by consensus.

Chairman Countryman asked if there were any public comments. Deb Archibald had questions regarding how library books are chosen and how to challenge a book.

Thayne Building Lease: Joe Heward and Lenny Pellitier from Thayne Town Council explained how the lease amounts are determined. The board agreed to have Richard sign a four year lease at the current rate of \$28,299.12 per year through June 30, 2027 if the Thayne Town Council agreed to those terms.
