## **Instructions:**

- 1. If a receipt is desired, return **ENTIRE BILL** (both Taxpayer's and Tax Collector's portion of the tax bill) with a **SELF-ADDRESSED**, **STAMPED** envelope.
- 2. Checks are accepted subject to clearance. Postdated checks will not be accepted. Returned checks are subject to a \$40.00 charge.
- 3. If Real Estate taxes are held in escrow, please forward tax bills to mortgage company.
- 4. Spring Washington Township Per Capita Tax is for residents that are 18-69 years old. If 70 & older when the bill is received please notify me immediately. All residents 18-69 years old are subject to per capita tax. If not received, also please notify me immediately. NOTE: Per Capita Taxes are personal taxes not associated with mortgages.
- 5. When paying taxes by mail, postmark, not check date, determines when tax is paid. All taxes paid on discount or face periods must be postmarked no later than the due date.
- 6. Other fees include <u>Duplicate bill fee \$5.00 per bill (receipts/lost bills) and Tax Certification fee \$25.00</u>. Note: **Credit/Debit Cards will not be accepted.**
- 7. AFTER 12/15/25 THE ONLY PAYMENT ACCEPTED WILL BE CASH, MONEY ORDER, OR CASHIER'S CHECK! IF PAYING BY CASH, PLEASE HAVE EXACT AMOUNT DUE. NO PERSONAL CHECKS WILL BE ACCEPTED.
- 8. **ALL TAX PAYMENTS MUST BE RECEIVED BY DECEMBER 31, 2025.** If using the DROP BOX, payments will be picked up by noon on December 31, 2025.
- 9. Unpaid REAL ESTATE TAXES will have a lien with York County Tax Claim Bureau after December 31, 2025. Unpaid PER CAPITA TAXES will be forwarded to a delinquent tax collection agency with added cost after December 31, 2025.
