The Washington Township Board of Supervisor's met at the Municipal Building on September 15, 2025, as advertised.

Supervisors Dan McGregor and Harlen Anderson, Jr. were present.

Chairman Dan McGregor called the meeting to order at 7:00 P.M. with the Pledge of Allegiance to the Flag.

Supervisor Harlen Anderson, Jr. made a motion to approve the minutes from August 18, 2025 meeting. Supervisor Dan McGregor seconded the motion.
