

Washington Township Board of Supervisor's Meeting March 17, 2025

The Washington Township Board of Supervisor's met at the Municipal Building on March 17, 2025, as advertised.

All 3 Supervisors were present.

Chairman Dan McGregor called the meeting to order at 7:00 P.M. with the Pledge of Allegiance to the Flag.

Supervisor Harlen Anderson, Jr. made a motion to approve the minutes from February 17, 2025 meeting.

Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor made a motion to approve the Treasurer's report as read and to be filed for audit. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor gave the following EMS reports. Penn State Health Life Lion EMS had a total of 215 dispatches for the month of January. Six were in Washington Township and 5 were handled by Penn State. For the month of February, they had a total of 196 dispatches, 3 were in the Township, 2 were handled by Penn State. Northern York County Fire Rescue EMS had 30 dispatches for the month of February. None were in Washington Township. Wellsville Fire Company was dispatched to 30 calls for the month, 1 was in the Township. Northeast Adams Fire & EMS was dispatched to 38 calls for the month of February, 3 were in the Township.

Subdivision Plans:

No plans were presented.

Business from the Floor:

Resident John Peters stated the guard rail needs repaired at the bridge at Detter's Mill and Blue Hill School Rd. The Secretary will call about this again.

Old Business:

Supervisors continued their discussion about the bid submitted for Trash pick-up from Republic Services. After much discussion with residents, Supervisor Dan McGregor made a motion to rejected the bid since they had no other bid to compare it with. Supervisor Harlen Anderson, Jr., seconded the motion. Motion carried.

Earl Hughes, property owner for Parcel LD-44, was present to asked if the Supervisors could waive the Township's Fee for his building permit. His numerous permits have been going on since 5/20/2010. He needs to apply for a new permit with Approved Code Services. He stated he is about 60% done with his home. The Supervisors will try to come up with a fair price, but the work will need to be completed within the 1 year that the permit is good for. There will be no more extensions!

Supervisor Dan McGregor made a motion to give a 90-day extension for the Groff Julius Land Development plan. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor made a motion to give The York Water Company also a 90-day extension for their subdivision plan. Supervisor Harlen Anderson, Jr., seconded the motion. Supervisor McGregor reminded residents of the Spring-Clean-up dates, April 9th & 10th -8:00-3:30 and April 11th, 8:00- 12:00.

New Business:

Supervisor Dan McGregor made a motion to have the Secretary advertise for bids to be opened at next month's meeting, for various stones, E-3 delivered, hot mix black top , line painting and fuels. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor informed residents that Ag Security Applications are due in the office by June 1st.

Supervisor Dan McGregor also informed residents that there is a new website for the Township. www.washingtontownshipc.net

Solicitor's Report:

Solicitor Sharon Myers had nothing additional to discuss.

Supervisor Dan McGregor made a motion to pay the bills out of the General Funds Account totaling \$23,936.59 and the State Account totaling \$157.78. Supervisor Harlen Anderson, Jr., seconded the motion.
