Northern York County Fire Rescue EMS had 28 calls in April, 2 were in the Township. Wellsville Fire Company had 20 calls, 3 were in the Township. Northeast Adams Fire & EMS had 27 calls in April, 1 was in the Township.

Wellsville Fire Company Assistant Chief, Vince Brown, stated interviews are over for paid fighters. They plan to hire 1 firefighter to work 6:00 A.M- 2:00 P.M. and the 2nd firefighter to work 8:00 A.M- 4:00 P.M.
