# Washington Township Board of Supervisor's Meeting February 17, 2025

The Washington Township Board of Supervisor's met at the Municipal Building on February 17, 2025, as advertised.

All 3 Supervisors were present.

Chairman Dan McGregor called the meeting to order at 7:00 P.M. with the Pledge of Allegiance to the Flag.

Supervisor Harlen Anderson, Jr. made a motion to approve the minutes from January 20, 2025 meeting. Supervisor Jeff Propps seconded the motion.

Supervisor Harlen Anderson, Jr. made a motion to approve the Treasure's report as read and to be filed for audit. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor gave the following EMS reports. There was no report from Penn State Health Life Lion EMS. Northern York County Fire Rescue EMS had for 45 dispatches for the month of January. None were in Washington Township. Wellsville Fire Company was dispatched to 47 calls for the month, 3 were in the Township. Northeast Adams Fire & EMS was dispatched to 42 calls for the month of January, 2 were in the Township.

## **Subdivision Plans:**

Supervisor Dan McGregor made a motion to approve the 3 lots subdivision plans for Judy Jarvis, Parcels JD-10 & JD-10A, as presented. Supervisor Harlen, Anderson, Jr. seconded the motion. Supervisor Dan McGregor made a motion to have the Secretary sign the None-Building Wavier for DEP. Supervisor Harlen Anderson, Jr. seconded the motion.

Supervisor Harlen Anderson, Jr. made a motion to approve the subdivision plan for Robert & Sharon Baumgardner, Parcel LC-20 as presented. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor made a motion to have the Secretary sign the None-Building Wavier for DEP. Supervisor Harlen Anderson, Jr. seconded the motion.

### Business from the Floor:

There was no business from the floor.

#### **Old Business:**

Supervisors continued their discussion about the bid submitted for Trash pick-up from Republic Services. The Bid was for a 3- year or a 5-year agreement. Several residents also commented on trash collection. Supervisor Dan McGregor made a motion to table this again until next month's meeting. Supervisor Jeff Propps seconded the motion.

Supervisors set a date to meet with Eric Naylor, with York County Land Preservation to discuss Zoning Ordinance changes for Minium Lot Size, Maximum Lot Size and requiring building on least productive land, which would give a farmer more points to enter into this program. The meeting was set for March 10 at 1:00 P.M. The Secretary will advertise for this workshop meeting.

## New Business:

Supervisors set the Spring Clean-up dates for April 9<sup>th</sup> and 10<sup>th</sup> 8:00-3:30 and April 11<sup>th</sup> 8:00-12:00. Supervisor Dan McGregor made a motion to appoint Engineer Byron Trout as the Floodplain Administrator for Washington Township and the Zoning Officer, Rebecca Bradshaw as the Assistant Floodplain Administrator. Supervisor Jeff Propps seconded the motion.

## Solicitor's Report:

Solicitor Devon Myers Kolomick was present for Sharon Myers. She had nothing additional to discuss.

Supervisor Dan McGregor made a motion to pay the bills out of the General Funds Account totaling \$14,878.18 and the State Account totaling \$3113.11. Supervisor Harlen Anderson, Jr., seconded the motion.

Supervisor Harlen Anderson, Jr. made a motion to adjourn the meeting at 7:38 P.M. Supervisor Dan McGregor seconded the motion.
