Washington Township Board of Supervisor's Meeting July 21, 2025

The Washington Township Board of Supervisor's met at the Municipal Building on July 21, 2025, as advertised.

All 3 Supervisors were present.

Chairman Dan McGregor called the meeting to order at 7:00 P.M. with the Pledge of Allegiance to the Flag.

Supervisor Jeff Propps made a motion to approve the minutes from June 16, 2025 meeting. Supervisor Harlen Anderson, Jr., seconded the motion.

Supervisor Harlen Anderson, Jr., made a motion to approve the Treasurer's report as read and to be filed for audit. Supervisor Jeff Propps seconded the motion.

Supervisor Dan McGregor gave the following EMS reports. Penn State Health Life Lion had a total of 161 dispatches for the month of May, 8 were in Washington Township. In June they were dispatched to 121 calls, 3 were in the Township. Northern York County Fire Rescue EMS had 37 dispatches for the month of June. 1 was in Washington Township. Wellsville Fire Company was dispatched to 38 calls for the month of June, 2 were in the Township. Northeast Adams Fire & EMS was dispatched to 44 calls for the month of June, 3 were in the Township. Vince Brown with Wellsville Fire Company updated Supervisors on repairs at the Fire Company and also reported the new Rescue/Engine should arrive late August or the beginning of September. They are preparing for the annual Fire Company Carnival which is the 3rd weekend of August.

Subdivision Plans:

Supervisor Dan McGregor made a motion to approve the 90-day extension request for the Sparks Estate Subdivision Plan for parcel JD-8, 57 Hofman Rd. Supervisor Jeff Propps seconded the motion. The extension will expire on October 20, 2025.

Supervisor Harlen Anderson, Jr. made a motion to approve the Subdivision plan for the Joan Steinke Estate as presented for parcel LD-44E. Supervisor Jeff Propps seconded the motion. The subdivision is to do an add-on to Parcel LD-44M.

Supervisor Harlen Anderson, Jr. made a motion to approve and have the Secretary sign the DEP Planning Waiver & Non-Building Declarations for this subdivision. Supervisor Jeff Propps seconded the motion.

Business from the Floor:

There was no business from the floor.

Old Business:

There was no old business to discuss.

New Business:

Supervisor Dan McGregor made a motion to approve Resolution 2025-02 authorizing Northeast Adams Fire & EMS to participate in the Federal Surplus Distribution Program. Supervisor Jeff Propps seconded the motion.

The Supervisors discussed a letter they received from Warrington Township in regards to the abandonment of the bridge on Peiffer Rd, by Warrington Township in the future. None of Washington Township Supervisors are in favor of closing this bridge. Solicitor Myers discussed some options that may take place. She advised the Supervisors to first respond to Warrington Township with a letter.

Solicitor's Report:

Solicitor Sharon Myers discussed the importance of completing a Solar Ordinance as soon as possible.

Supervisor Dan McGregor made a motion to pay the bills out of the General Funds Account totaling \$15,591.93 and the State Account totaling \$6,849.14. Supervisor Jeff Propps seconded the motion.
