AGREEMENT 1. <u>DEPOSIT REQUIREMENTS:</u>

a. A \$ 500.00 non-refundable deposit will hold your pup, if we cannot provide the puppy of choice in a current litter, the deposit may be transferred to another litter or pup. After 3 litter options are offered and turned down the deposit will be non-refundable and no longer be valid towards another puppy or litter option.

2. **PAYMENT:**

a. No personal checks for final payment, final payment due two weeks prior to picking puppy up at 8 weeks of age or having the puppy shipped at 8 weeks of age. Failure to comply with these terms will result in the purchaser's deposit being forfeited and breach of contract. We accept cash, cashier's checks, Zelle, Venmo and Pay Pal if using pay pal add 3.5 % to the total this is what pay pal charges and it must be included in the price. Deposit and this signed contract must both be received by breeder to secure reservation.

3. **DELIVERY OF PUPPY:**

a. Buyer is responsible for the coordination and fees related to picking up their puppy. Puppies are released to the new owner at **8 weeks** of age. Buyer must pick the puppy up at 8 weeks of age. If puppies are beyond **8 weeks** of age the breeder will charge the buyer \$20.00 a day thereafter up to **10 weeks** of age at which time the contract will void and deposit will be non-refundable.

4. **<u>GUARANTEES/WARRANTY:</u>**

- a. **7-Day Guarantee** This puppy is guaranteed to be in good health and has been vaccinated and dewormed properly for the puppy's present age. The Breeder will provide accurate health records on the purchased puppy. This guarantee is warranted to the original purchaser for seven days. After 7 days the Breeder accepts no responsibility to guarantee.
- b. Other Guarantees This puppy is guaranteed to the original buyer for (2) two years against hereditary/genetic diseases after such time the Breeder accepts no responsibility to guarantee. All Full Registration breeding dog's must have hips tested with either OFA or Penn-Hip before breeding and have their required health tests done DM, NEwS, Thyroid, Cardiac, EYES, VON WILLEBRANDS or this contract is null and void. If dog is found to have a serious hereditary/genetic disease a replacement puppy of equal value will be given when available. Documentation from licensed veterinarian must be given.
- c. **3-Day Warranty** The buyer must have the puppy examined by a licensed veterinarian within three days. (Breeder is not responsible for vet bills.) Should the veterinarian find this puppy to have a serious life threatening illness or disease, (excluding, parasites or coccidian) breeder will replace it with another puppy of equal value, when available.
 - i. 3-Day Warranty COST COVERAGE EXCEPTION; Breeder will cover umbilical hernias and undesirable bites only, with up-to \$150 for repair as needed. This is only covered in the 3-day warranty and must be confirmed by a Veterinarian with documented proof of illness from a licensed veterinarian including contact information and licensure for the veterinarian.
 - ii. Breeder must be notified of veterinarian's findings no later than 3 days after purchase of puppy with documented proof of illness from a licensed veterinarian including contact information and licensure for the veterinarian.
 - iii. The purchased puppy must be returned to Breeder and accompanied with the original documented proof of illness from a licensed veterinarian including contact information and licensure for the veterinarian. Puppy must be returned to Breeder within 7 days after final pick up of puppy unless a mutual arrangement in writing with Breeder has been coordinated and agreed upon. Failure to return the puppy within the contract

term of 7 days or an agreed upon time will result in buyer breaching this contract and it will become void. (Breeder not responsible for transportation costs or any other related fees.)

- iv. Breeder reserves the right to have the returned puppy examined by a licensed veterinarian of their choice to verify and confirm diagnosis of puppy before replacing it. If failure to justify return of puppy by a legal licensed veterinarian or breeders veterinarian does not concur with buyers veterinarian all sales are void and buyer will forfeit their deposit and will receive a 50% refund of remaining balance based on no evidence, no proof or breeder's veterinarians disagreement with the illness of puppy.
- d. **Guarantee is VOID** on replacement puppies if defects are found after 3 day warranty or not satisfied with puppy and it is your choice to return pup to breeder or keep the puppy at your own expense. NO refund or replacement puppy will be issued.
- e. **NO Guarantee** We cannot guarantee color or show quality but we can give our best-educated and honest opinion. We breed for the love of the Poodle in mind, every effort has been made by the breeder to produce a litter both physically and mentally sound, still somethings are in Mother Nature's hands.

5. CONTRACT REQUIREMENT (NuVet REQUIRED)

- a. Dogs should be spayed/neutered around 6 months, but NO later than 10 months of age. Once proof is received then AKC papers will be sent to buyer. All to be done by mail no pictures from receipt will do MUST have original copies for my paper work for AKC.
