



## **Fashioned for The Kingdom Boutique, LLC – Master Consignment Contract**

Fashioned for The Kingdom Boutique, LLC appreciates your business and as one of our valued Consignors, we are committed to selling your designer items at the best possible price. To enable us to operate efficiently, we ask that you comply with the following policies:

1. Consignments splits are 70% of the final sales prices of the fashion item: Consigner gets:
  - a. 70% of the purchase price for a sale
2. We accept Upscale designers, gently worn, clean, free of odors, pressed and ready to be sold. Fashioned for The Kingdom Boutique, LLC, at its sole discretion, retains the right to have merchandise cleaned or repaired at the consignor's expense if items are deemed to not be "ready to sell". Fashioned for The Kingdom Boutique, LLC, reserves the right to return any and all merchandise to Consignor prior to the expiration of the consignment agreement period and for any reason.
3. All fashion items will be priced at Fashioned for The Kingdom Boutique LLC's discretion. Fashion items will be consigned, on website, for a maximum of 80 days.
4. If Consigner requires a specific sale price for his/her merchandise, the Consignor must explicitly state the required price. If the merchandise does not sell within 60 days at the Consignor's required price, Fashioned for The Kingdom Boutique, LLC reserves the right to discount the merchandise. The sale of the discounted merchandise will not affect the commission percentage earned by Fashioned for The Kingdom Boutique, LLC as outlined in paragraph 1.
5. Fashioned for The Kingdom Boutique, LLC's reserves the right to hold sales events offering additional discounts. The sale of the discounted merchandise will not affect the commission percentage earned by Fashioned for The Kingdom Boutique, LLC as outlined in paragraph 1.
6. Checks are printed once a month for items sold the preceding month. Checks are ready by the 10<sup>th</sup> of the month and an email will be sent to notify the Consignor when the check is mailed or ready for pickup. Fashioned for The Kingdom Boutique, LLC is not responsible for any undelivered or mis-delivered emails. Checks will be mailed on the 11<sup>th</sup> of the month to the mailing address provided last, and on file. We are not responsible for any check lost or stolen in the mail Consignor is responsible for any stop payment fees prior to check reprint; currently the fee is \$35 and is subject to change without notice. No cash payments NO EXCEPTIONS. Any check(s) not cashed or picked up after 12 months from issue will become property of Fashioned for The Kingdom Boutique, LLC.



7. At the end of the consignment period (80 days), it is the responsibility of the Consignor that wish their items returned to notify us by email by the pick up/expiration date. Fashioned for The Kingdom Boutique, LLC is not responsible for any undelivered or mis-delivered emails. When the items are ready for pick, the consignor will receive a courtesy email or phone call when items are ready for pickup. The consignor has 15 days for pickup. Items left after 15 days will become property of Fashioned for The Kingdom Boutique, LLC and can continue to be sold or donated to a charity our our choice. Consignor is responsible to keep track on when their items expire. If we do not receive notifications or pick up by the "Pick Up/Expiration Date", items will be donated to a charity of our choice.
8. Fashioned for The Kingdom Boutique, LLC is not responsibly for any lost to theft, vandalism, fire, natural disasters or any other reason.
9. Fashioned for The Kingdom Boutique, LLC accepts only authentic designer items. Consignor guarantees the authenticity of all merchandise that they consign. Any Consignor item delivered to Fashioned for The Kingdom Boutique, LLC and deemed to be counterfeit by Fashioned for The Kingdom Boutique, LLC or any qualified 3<sup>rd</sup> party, will either be returned to the Consignor. The consignor has 10 days to plan for receipt of item. Items left after 10 days will become the property of Fashioned for The Kingdom Boutique, LLC and will be donated to a charity of our choice.
10. The Consignor guarantees that he/she is the true and lawful owner of all merchandise consigned with Fashioned for The Kingdom Boutique, LLC. Consignor agrees to indemnify and holds harmless Fashioned for The Kingdom Boutique, LLC not responsible for any damages arising from any and all claims, demands, losses, causes of action, damage, lawsuits, judgments, including attorney fees and costs, to the extend caused by or arising out of or relating to the unlawful ownership of merchandise.
11. Fashioned for The Kingdom Boutique, LLC reserves the right to terminate or amend the consignment agreement at any time and without notice. Update Contracts are available on request.
12. Fashioned for The Kingdom Boutique, LLC agrees to maintain documentation of all contractual agreements and sale transactions on behalf of the Consignor, but it is ultimately the repsonsibility of the Consignor to maintain all accurate records of merchandise consignments and contract expiration.
