### Eligibility

**Cover crop applications will be accepted July 1, 2023 through November 30, 2023.**

- 50/50 Cost Share Rate not to exceed \$3,000.00 (Reimbursed 50% of expenses, up to \$3,000)
- One application per farm number/landowner
- Cost share available for seed cost only up to \$30 per acre
- Wheat as a single species is not eligible
- Deadline to turn in bills for payment is November 30, 2024
- Applicants are subject to a random spot check

## WCCD Gateway & Barn Access Erosion Control BMP Guidelines

The purpose of this program is to help Warren County landowners with the necessary means to repair gateways/barn entrances to reduce degradation, soil erosion and pollution.

### Eligibility

**Heavy use area applications will have from July 1, 2023 through May 31, 2024 or until funds are depleted.**

- 50/50 Cost Share Rate not to exceed \$1,500.00 (Reimbursed 50% of expenses, up to \$1,500)
- One application per farm number/landowner
- Cost share available for gravel and woven wire geotextile fabric
- Must have an updated Ag Water Quality Plan
- Only gateways and barn access points eligible, does NOT apply to driveways
- Deadline to turn in bills is 90 days (based on application date), not to exceed May 31.
- Applicants are subject to spot-check.

### Specifications

- Project must be completed in 90 days (based on application date), not to exceed May 31.
- Must use non-woven filter fabric
- Must install at least 6 inches of stone to secure fabric
- Ensure full coverage of filter fabric by the rock
- Submit receipts, pad measurement and photos for a payment request
- Maintenance must be provided for 5 years
  
- Max of 30' length for gateways
- Max of 15' length for barns
- Width depends on gate size or barn door
- Rock size should be DGA, #610, #57 or #8

*To Figure Estimated Quantities Per Gate or Barn*  
 $(L+1) \times (W+1) \times (0.11) = \text{Sq. yards of non-woven filter fabric}$   
 $L \times W \times .028 = \text{tons of rock}$

*Example: To figure quantities needed for 18' wide gate with 30' length*  
 $(30+1) \times (18+1) \times (0.111) = \text{square yards}$   
 $31 \times 19 \times .111 = \mathbf{65.4 \text{ square yard of filter fabric}}$   
 $30 \times 18 \times .028 = \mathbf{15.1 \text{ tons of rock}}$

## Farm Cleanup Assistance

The purpose of this program is to help Warren County landowners with the necessary means to remove heavy materials at a farm dump site. In turn, the cleanup will better water and soil quality in Warren County.

### **Eligibility:**

- The farm must be located in Warren County and have a farm serial number (FSN).
- One application per farm number/landowner
- A farm dump is defined by the KY EPA as “an area on a farm used to dispose of household garbage, junk furniture, appliances, farm chemicals, and anything else that is no longer usable”.
- A KY AG Water Quality Plan is required.
- WCCD will fund up to four cleanups in the county per fiscal year (July 1 – June 30). All applications are due by September 1, 2023 and will be reviewed/by the WCCD board of Supervisors.

### **Responsibilities:**

- If funded, applicant is responsible to cover all costs associated upfront. Reimbursement will be made after the cleanup is completed.
- Receipts and documents for any contracted work, recycling fees, proper disposal, etc., must be provided for a reimbursement.
- Only hired help/professionals/contractors are eligible; yourself or family members may *not* be paid.
- The cleanup should be completed by May 31, 2024.

### **Specifications:**

- You may only haul waste to a permitted dump site.
- Only licensed contractors may be used for proper cleanup if a reimbursement for work is needed.
- WCCD is not liable for injury.
- Up to \$5,000 will be reimbursed to the applicant, receipt dependent, at a 50/50 cost share rate.
- A person engaged in agricultural or forestry production who has failed or refused to comply with agriculture water quality planning and has been deemed a "bad actor" under KRS 224.71-130 shall lose eligibility for further cost share assistance. Therefore, this program is not available to landowners who have been deemed a bad actor by the KY DEP.
- You are subject to field visits after the cleanup is complete and for maintenance checks.
