I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
- I confirm that I have not been refused an ACU Licence, nor had an ACU Licence suspended, nor have I been excluded from any ACU competition.

### 2 Announcement

The Castle Colchester MCC will hold a National Trial for solo motorcycles on Sunday 2<sup>nd</sup> February, to be held under the National Sporting Code of the ACU, the Trials Standing Regulations, the ACU Normandale Masters Trials Championship Regulations and any Final Instructions issued in accordance with TSR2.1.

### 3 Entries

To be made online via Sport80, **entries open 2<sup>nd</sup> January, CLOSE Thursday 23<sup>rd</sup> January 2025**. The entry fee, which includes ACU entry subscription Competitors Third Party Insurance, off Road Insurance, Personal Accident Insurance will be **£35.00**. Entry fees (minus a £3.00 admin fee) will only be returned if the meeting is cancelled or postponed. Entries will be **limited to 130** with preference to the championship classes. Starting order will **in class** and is decided by **Receipt of entry**, early entry equals early riding number.

### 4 Course and Time limit

**The course will be one lap approximately 20 miles in length (connected by public roads) with approximately 35 sections.** It is the rider's responsibility to ensure that both he and his machine are legal for the purpose.

**The individual time schedules will be in the Final Instructions.**

### 5 Routes and Classes

**There will be up to two routes through each section, the main route will be marked with RED and BLUE cards with a YELLOW (Harder) deviation.**

<b>Route 1</b>	Red & Blue route with yellow (Harder Deviations)	Class 1 Over 40 (at the date of the competition) Class 7 Open – Hard (Non Championship)
<b>Route 2</b>	Red & Blue	Class 2 Over 50 (at the date of the competition) Class 3 Over 60 (at the date of the competition) Class 4 Aircooled Mono (no rider age restriction) Class 5 Twinshock (Must have twin rear suspension units and drum brakes as at the time of manufacture) Class 6 Open Pre65 (Non Championship) Class 8 Open

**Drivers must follow the section deviations according to their class.**

### 6 Awards

Phil King Trophy awarded to the best performance by a Castle Colchester rider on a championship route.

### 8 General

This is a no stop trial as per TSR 22b. Late starters will be penalised 1 mark per minute to a maximum of 20 minutes and will be disqualified thereafter as per TSR 16. Ties will be decided as defined in TSR 23.

The organisers reserve the right to issue further final instructions that will have the force of these regulations.
