1. To keep the market diverse, please note that we have limited spaces for each category listed below. Spaces are available on a first come, first served basis.
2. Vendors must vend on both days (No Exceptions)
3. Set-up time will be on Friday August 19th, 2022 from 5 pm to 8 pm and August 20, 2022 from 8 am until 11 pm. No vendor may set-up after 11 am on August 20th, 2022 (No Exceptions Allowed)
4. This is a rain or shine event and no refunds will be honored.
5. Vendors must obtain credentials for each worker not to exceed (4) per vendor
6. Vendors must name Florida Community Corporation dba Eatonville Main Street as additionally insured.
7. All vendors by acceptance and payment understand that Florida Community Corporation dba Eatonville Main Street are indemnified from all claims of attendees and/or workers of the event and Florida Community Corporation dba Eatonville Main Street shall no be any party to said claims.
8. All vendors are responsible for bringing their own supplies to set up, including table, tent, chairs, table covering and staff. No event staff will be able to assist vendors with set up and break down.
