1. We, the undersigned, declare that the company will carry on its activities for the benefit of the community, or a section of the community². The Community includes residents of the whole of Bonnyrigg and Lasswade districts. ³

The company's activities will provide benefit to ...

the Bonnyrigg and Lasswade communities, in particular to encourage members of the Community to participate in the development and sustainability of the Bonnyrigg Rose Football Club's historic ground, facilities and Social Club building at New Dundas Park, Bonnyrigg, Midlothian, all established in 1881. Members of the Community will be able to become "stakeholders" in the current and future development of New Dundas Park.

The "1881 Club" was set up in March, 2024, by a group of eight residents and supporters of Bonnyrigg Rose Football Club. The initial group of eight formed a committee and Constitution. A Bank account was opened as a constituted Club. The group began to raise awareness of their intentions for improvements and the redevelopment of New Dundas Park through social media and local fundraising events and by early August, 2024, the membership had increased to 40 with several notes of interest from other supporters. Membership to the "1881 Club" is through monthly voluntary donation of nominal amounts from £10 to £18.81 per month, depending on affordability for the member. The membership nominated the five directors listed in this application.

The "1881 Club" shall have no influence or involvement in the function or development of the Football Team.

	New Dundas Park is situated in centre of the local community and has long been part of the community. However we believe that the ground can be more accessible and attractive to more people and groups. We believe having access to improved facilities at New Dundas Park, Bonnyrigg will: • Add to the limited community amenities at local schools and church buildings. • Provide additional disability access and usage at the Football Ground. • Improvements to the currently under used Social Club to provide for use by local groups such as Dance Group, Choir, and clubs for the elderly, as well as providing a suitable meeting place for other Community Groups. • Encourage the use of the ground for other football and sports groups with better facilities

To encourage supporters of Bonnyrigg Rose Football Club and members of the Community to participate in the development and sustainability of the Club's historic ground and facilities at New Dundas Park, Bonnyrigg, Midlothian. Bonnyrigg Rose FC is financially self sufficient but there is a general acceptance that the ground in its current state is not as inclusive to the whole community as it could be. For example, there is limited covered seating and toilet facilities This in turn has an impact on club revenue and local engagement. In early 2024, many members of the community and supporters of the Football Club began to meet and discuss how they could assist in the development and sustainability of the historic ground. A committee was elected and a group now known as the "1881 Club" was formed, governed by a Constitution. It was quickly realised that the formation of a Community Interest Company would provide transparency and legitimacy to the intentions of the "1881 Club" and allow members to become stakeholders in future development by way of membership donations.

Benefit to the Community (Continued)

A substantial demographic of the population of Bonnyrigg and Lasswade who attend or would like to attend the football at New Dundas Park are elderly people and people with disabilities. Current facilities such as access, seating and toilets, although available, are currently limited, restricting the number of elderly and disabled people who are encouraged to attend. This is particularly prevalent during inclement weather or during the winter months. This means many in the community are denied the opportunity to see Midlothian's first and only SPFL team in action.

The 1881 Club and Bonnyrigg Rose FC is giving priority in the Short Term to raising funds to provide an additional disabled access gate at the west end of the ground together with additional seating, wheel chair access, and disabled toilet(s). The local Community and supporters of the 1881 Club will raise funding for this project through fundraising events, membership and individual private donations. These short term improvements will enhance the experience of attending and supporting the Football Club for an increased number of elderly and disabled people in the Community.

There is now an active volunteer group which is ensuring funds are used sparingly. However, of equal benefit has been the physical and mental benefits for volunteers. We know that this volunteering is allowing people from different parts of the community to connect and break down barriers

In the adjacent Social Club, the 1881 Club has already liaised with the staff to provide funding to improve the large function hall to allow use by Community dance groups and pensioners. The 1881 Club has taken the lead on this by organising periodic pre match 'Pie and Pint' events. These generate a modest income but we know are increasingly appreciated by older supporters especially as a safe and welcoming place for chat and contact.

The 1881 Club will work closely with Bonnyrigg Rose FC and to agree on a medium and longer term plan for ground development. As well as meeting licensing requirements these will focus on fan experience (such as covered seating) and greater community inclusivity (such as facilities or other sport groups to use the ground) .

It is the intention of the 1881 Club to raise funding through local fundraising events and explore other avenues such as such as Crowdfunding, Sport Scotland and The National Lottery.
