Annual Registration:

1. Registration must be completed prior to student's entrance into class.
2. Registration Fee and first month tuition (non-refundable) must accompany this form:
 - \$30 - per student, \$20 per additional student in the family

Tuition Payment:

1. Our dance year runs from September - May. (Our summer registration begins in April).
2. Tuition is for the full year of the class and not pro-rated due to absences. We encourage our dancers to make up classes that they have missed. *Please note, Tuition is non-refundable.
3. For your convenience we have several different payment plans available: (Payments are based on our dance year)

5. A \$35 returned check fee will be assessed on any returned check.
6. Costumes will not be distributed until tuition is paid in full for the year and all fees are paid.

Late Fee(s):
