**Sub:- To bring to the notice of the Hon Prime Minister the grave error in the proposed alignment in NH 66 which will cause serious damage to 1500-year-old Thiruvangur Sree Narasimha - Parthasarathy Temple, Kozhikode District, Kerala.**

Respected Sir,

Greetings from Haindaveeyam Foundation!

This is to bring your kind information that, the Haindaveeyam Foundation is a Hindu organization formed to provide holistic development and social services such as educational assistance, medical support, and motivational and leadership support for the poor and marginalized Hindus in the society. Haindaveeyam stands for the protection, welfare, and unity of the Hindu community and promotes the unity and integrity of India. It was formed in February 2020 with a registered office in Hyderabad. Now we have formed district-level units in 14 districts in Kerala to work closely with the Hindu community and develop pragmatic and meaningful programs for helping the neediest Hindus.

We are seeking your kind attention to save the temple from the conspiracy to demolish the Sri Narasimha Murthy - Parthasarathy temple which was installed by Lord Parasurama as part of the efforts of some vested interests in the name of road development.

Thiruvangur Sree Narasimha - Parthasarathy Temple is located in Chemancheri Village, Kozhikode District, Kerala State. Certified by the Department of Archaeology to be more than 1500 years old, this temple is the soul of an entire region. This temple is also included in the list of major pilgrimage centres of Kozhikode district. This temple was completely destroyed during the Hindu genocide and aggression against the Hindu institutions in Malabar by the Tipu Sultan, the most despotic and infamous ruler of Mysore. After that, this area was covered with forest for many years. An ashram was established near the temple and Satsang activities were conducted. This temple complex

In 1974, the ashram authorities cooperated wholeheartedly to give the necessary land for the road in this part without losing the temple property in the acquisition of 30 meters of width for NH 17. Moreover, the road survey conducted over Swamiji's Samadhi place was heartbreaking, this village was enduring for the general development of the country. After this, in 2009, a survey was conducted to widen NH 17 to 45 meters to make it a six-lane road. However, 3 new houses were constructed on the land which was included in the 1974 survey and which is opposite said Temple. For these homeowners who are anti-Hindus and active workers of CPM, the authorities have done a survey through the temple property by completely reversing the course of the road in the 2009 survey.

The temple management committee had submitted complaints to the NHAI authorities, Kozhikode district collector, and the UPA-led central government against this blatant injustice. Complaints were not redressed. However the leadership of the temple management committee approached the Kozhikode District Collector took charge in 2016, and requested to solve the problems. He examined the matter and took a position not to evacuate the road encroachers and suggested that the temple land including the lamp post should be given away without damaging the sanctum sanctorum. Although 18.50 cents of temple land will be lost for this, the temple management committee leadership accepted the Kozhikode district collector's proposal in peace that the temple can be maintained without demolition. According to this, the Temple wall was demolished and a new boundary was built next to the flagpole of the temple. But later, Prashant IAS, The then District Collector of Kozhikode, joined as staff of Hon. Union Minister Alphonse Kannanthanam and was moved to Delhi. Taking advantage of the situation, the officials once again created problems with the argument that the temple should be demolished. To add to it, there was also a move at the official level to portray the land given by the temple as unauthorized land to avoid paying compensation to the temple.

Meanwhile, based on the petition given by the temple management committee, some officials came to inspect the site and replied to the authorities by preparing a fake report saying that it is advisable to demolish the temple to avoid any major protests by demolishing the mosque in the opposite side of the temple when the curve in the alignment is completed as per the demand of the temple management committee.

This report, prepared under the pressure of anti-Hindu people, is completely

concerned who acted as disciples of Tipu to demolish the temple by preparing a false report to protect the vested interests. But Hindu devotees in the village suspect that the court's stance is limited as the opposition lobbies are strong and the state government has its support.

Therefore, we request you draw your immediate attention to the matter and appoint a high-powered committee from outside Kerala to study the issue and submit a report. We request that a decision be taken to protect the temple after being convinced of the truth and to give adequate compensation for the land lost to the temple.
