JUDGMENT

Ravikumar, J.

Substantially the same grievance is raised in all the writ The grievable decisions qua the petitioners, who are petitions. devotees, are concerned were taken by the Travancore Devaswom Board (for short 'TDB' only). According to them, TDB resolved to lease out unused temple properties for cultivation and also to effect sale of used movables in temples including pooja articles, shallow vessels made of bell-metal (Uruli), large vessels, utensils, oil-lamps as also oblated ornaments of gold and silver etc. In regard to the leasing out of temple properties for cultivation the TDB took a decision as per proceedings bearing No.ROC 3986/20/M dated 15.5.2020. The same is produced as Ext.P5 in W.P.(C)No.10429 of 2020. In fact, Ext.P1 in W.P. (C)No.10429 of 2020 is an order bearing No.ROC 4939/11/M dated 30.01.2020 in respect of appropriation (വിനിയോഗം) of oblated ornaments of gold and silver and it did not reveal any decision taken to effect sale of used utensils and oil-lamps and the decision thereunder is to segregate gold, silver and antique ornaments, record their details in registers and to prepare a mahazar in respect of the different items. True that those acts constitute the first step towards deposit of such

oblated gold and silver ornaments, not required for ceremonies in temples, in the 'gold bond' scheme of the Central Government. Various grounds have been raised by the petitioners to challenge the aforesaid actions on the part of TDB. Affidavit and additional affidavit have been filed in W.P.(C)No.10429 of 2020 by the second respondent. In W.P. (C)No.10341 of 2020 a counter affidavit has been filed on behalf of respondents 1 and 2 therein viz., TDB and its Commissioner. In fact, a statement has also been filed therein. A Statement has been filed in W.P.(C)No.10502 of 2020 and a counter affidavit has been filed in W.P. (C)No.11283 of 2020, by TDB and its Commissioner. Obviously, the same has been taken by the respondents statements/affidavits and counter affidavits filed in all the writ petitions.

- Heard the learned counsel for the petitioners as also the learned standing counsel appearing for the respondents.
- 3. We will firstly consider the decision to lease out temple properties for cultivation. In that regard, it is relevant to note that along with the additional affidavit dated 29.6.2020 filed by the 2nd respondent in W.P.(C)No.10429 of 2020 proceedings bearing ROC.No.3986/20/M dated 20.6.2020 has been produced as Ext.R2(c). It would reveal that the earlier order dated 15.5.2020 carrying the decision to lease out properties belonging to the TDB was cancelled. In

the light of the said order nothing survives for consideration in regard to the aforesaid decision and grievances as the grievable decision is not now in force.

4. The learned Standing Counsel for TDB would further submit that it is evident from the said proceedings dated 20.6.2020 that though the objectionable decision to lease out properties to organizations and individuals was cancelled it is decided by TDB to utilize the land effectively through staff and Temple Advisory Committees. In fact, the counter affidavit filed by respondents 1 and 2, TDB and its Commissioner, in W.P.(C)No.10341 of 2020 would reveal the decision in that regard. Obviously, the decision is to cultivate the land with crops which suit the soil of the particular area concerned and that the agricultural department has offered to supply necessary seeds, fertilizers, technical help etc. That apart, it would reveal that the present proposal is to cultivate vegetables, flowering plants, plantains, tuber crops, paddy, coconut, arecanut, grass, medicinal plants etc. in accordance with the suitability of the soil of the area and also the requirements of the temple concerned. The learned Standing Counsel would further submit that based on the same policy the lands available in other institutions belonging to TDB is also proposed to be used for the aforesaid purposes. The learned counsel for the petitioners also

submitted that the said proposal is to be implemented in letter and spirit. We also feel that the said proposal to carry out such cultivation without leasing out the properties is a welcome change in the policy and an ideal decision and certainly keeping arable land uncultivated is not advisable.

5. Regarding the grievance on segregation of oblated ornaments of gold and silver items, antique ornaments etc., evidently, the apprehension of the petitioners is that the segregation is for the purpose of effecting sale without obtaining permission of this Court. The learned Standing Counsel would submit that as is evident from Ext.P1 order in W.P.(C)No.10429 of 2020 presently the decision is only to segregate such materials and also to prepare a mahazar/inventory therefor. A close scrutiny of Ext.P1 order would reveal the avowed purpose. The 'epitome' given atop the order needs reference in view of the submission and it reads thus:-

Thus, the epitome would suggest it is a proposal regarding appropriation of oblated gold and silver articles, not required for

ceremonies in temples, pursuant to a report of a study committee on Income of Temples. What is stated immediately below 'reference' would further reveal that their segregation is actually the first step for depositing them in gold bond scheme of the Central Government, for generating revenue. It reads thus:-

"ക്ഷേത്ര വരുമാന പഠന സമിതിയുടെ റിപ്പോർട്ടിലെ നടവരവായി ലഭിച്ചിട്ടുള്ള സർണ്ണം വെള്ളി വകകളുടെ വിനിയോഗം സംബന്ധിച്ച ഖണ്ധിക IV ൽ നടവരവായും കാണിക്കയായും ലഭിക്കുന്ന സർണ്ണം വെള്ളി വകകളിൽ ക്ഷേത്രത്തിലെ ചടങ്ങുകൾക്ക് ആവശ്യമില്ലാത്ത ടി വകകൾ സുരക്ഷാ പ്രശ്നം കൂടി കണക്കിലെടുത്ത് ഡിപ്പാർട്ട്മെന്റ് ചട്ടങ്ങൾ പാലിച്ച് ഇൻഡ്യാ ഗവണ്മെന്റിന്റെ റിസർവ്വ് ബാങ്ക് മുഖേന പ്രഖ്യാപിച്ചിട്ടുള്ള ഗോൽഡ് ബോണ്ടിൽ നിക്ഷേപിച്ചാൽ ആയത് സുരക്ഷിതമായിരിക്കുമെന്നും ഡിപ്പാർട്ട്മെന്റിന് വരുമാനം ലഭിക്കുന്നതാണെന്നും നിർദ്ദേശം ഉണ്ട്. ടി വിഷയം ചർച്ച ചെയ്ത് ബോർഡ് ചുവടെ വിവരിക്കുന്ന തീരുമാനം കൈകെങ്ങും."

However, we do not think it necessary to delve into the matter any further in view of the submission made by the learned Standing Counsel for TDB Sri.G.Biju that even after segregation those articles would not be appropriated in any manner without obtaining permission from this Court.

6. From the aforesaid submissions and materials on record it is thus evident that, as on today, the decision of TDB is only to effect segregation of such materials. We do not find any objectionable aspect in the said action of segregation. Needless to say that after such segregation mahazar/inventory in respect of each and every type of items shall be prepared. In view of the submission made by the

learned Standing Counsel that none of those items would be appropriated without obtaining permission of this Court we are of the view that there is no room for any apprehension for the petitioners that after segregation without obtaining permission of this Court those materials would be sold out or appropriated in any manner. The submission in that regard, referred to hereinbefore, made by the learned Standing Counsel is recorded.

Accordingly, the writ petitions are disposed of with the aforesaid observations and recording the submissions made as above.
