General Care

- This dog will receive prompt medical care for any condition that may arise.
- This dog will be fed good, high-quality food (We feed our poodles Victor Hi Pro Plus all life stages or Victor Ocean Fish Formula) plus give NuVet supplements.
- This dog will receive routine annual veterinary care including health exam and vaccines at a minimum per your veterinarian's recommendations.
- This dog will receive regular grooming to include bathing, nail trimming, ear cleaning, and coat clipping to keep dog comfortable and free of matted hair (unless the dog is going to be corded). Poodles generally need to be clipped every 4 - 8 weeks with daily brushings in between if puppy/dog is kept in longer coat.
- This dog will be confined in an adequate enclosed area, or on leash, and not allowed to roam at will.
- Puppy will receive basic training classes that practice positive reinforcement.

Spay/Neuter Agreement

- This puppy will come with “AKC LIMITED REGISTRATION” only. Limited registration will allow participation in performance sports (Agility, Fastcat, Rally, Obedience). It doesn't allow entrance into AKC conformation shows or give breeding rights (which means no litter produced from said puppy is able to be registered with AKC).
- The dog will be spayed /neutered by the time the puppy is 18 - 24 months (1½ - 2 years). Written proof of spay/neuter will be supplied to breeder within 60 days after the procedure was performed.
- This dog will **not** be used for ANY breeding. If a litter is produced using this dog either accidentally or intentionally then this dog and all offspring will be immediately returned to Seller. If the seller becomes aware of any offspring created by the mating of this dog, the seller shall have recourse through the courts for damages in the amount of \$25,000 (Twenty-Five thousand dollars) per litter produced by said dog.
- This puppy/dog shall never be rehomed to a doodle/merle breeder or placed in the care of a doodle/merle breeder.

_____ Buyer Initials

THE BUYER AND SELLER AGREE TO THE FOLLOWING PROVISIONS OF THE SALE. SELLER makes the following agreement at the time of BUYER taking possession of the dog:

- The dog is in good health, free of known contagious diseases and has had vaccinations required for its age at the time of this agreement. We offer a one-year health guarantee against genetic health issues.
- The dog had a physical examination performed by a qualified veterinarian between 6-8 weeks of age and was found to be healthy.
- WE DO NOT GUARANTEE THE SIZE OR COLOR OF YOUR NEW PUPPY! Only the health of the puppy at the time of purchase! After taking your puppy home all vet bills are the responsibility of the new owners. As a breeder I am not responsible for color, issues with bite or teeth, temperament problems, accidental death, biting or other situations that may be caused by new environment and care.
- If the buyer pays in full for a puppy and at any time before the BUYER takes possession of the puppy, if the Buyer is not satisfied with that puppy, the funds are transferable to another available puppy at that time or on a future litter. If a refund is requested, it will be given when that puppy resells minus the \$500 deposit.

- We offer Shipping of the puppy within the USA and international for an additional fee. Charges include airfare, travel crate, vet check, health certificate, and trip charge. All flights originate from Phoenix Sky Harbor International Airport
- We also offer flight nannies both national and international; prices vary (we put you in touch with one of our nannies, you make the arrangements and pay them directly, only available for puppies 12 weeks and younger, as they need to fit in a carry-on bag)

The buyer must keep the puppy current on all vaccines including rabies.

BUYER certifies by signing this agreement that the dog will live with BUYER, will have adequate exercise, nutritious food and necessary health care from a licensed Veterinarian, BUYER also certifies, by signing this agreement, that he/she is not acting as an agent in this purchase; that the BUYER will not sell this puppy to a pet store, guard dog business or a medical research facility.

Under no conditions and at no time during the life of the dog, will SELLER pay or assist in paying veterinary expenses after the dog is purchased, including any such expense directly or indirectly related to any inheritable/genetic defects.

- The puppy will be held for the buyer until the puppy is at least 8 weeks of age (Puppies will not be sold before then)
- BUYER understands that full payment is due by the time puppy is 6 weeks old.
- Balance of purchase price and any shipping charges are to be paid in full By Zelle before puppy is shipped (If using the flight nanny, their charges are to be paid directly to the nanny when flight arrangements are made).

In the event the BUYER is unable to keep the dog for any reason, the BUYER agrees to immediately return the puppy/dog back to the breeder without financial restitution. If another home is found, the breeder must approve before the puppy/dog is placed. Breeder has the first right of refusal.
