I accept responsibility for the condition and adequacy of my bike and equipment. I will ride wearing a helmet that satisfies the requirements of the U.S. Consumer Product Safety Commission for bicycle helmets. I assume all responsibility and liability for the selection of such a helmet.
- 4. I have no physical or medical condition which, to my knowledge, would endanger myself or others if I participate in MTCCLA activities, or would interfere with my ability to participate in such activities.
- 5. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Club officers and / or ride leader immediately; and,
- I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS MTCCLA and their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors and advertisers ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
