- (3) By placing the (Exhibitors) signature and stamp on this (Booking Form) the (Exhibitor) assumes all and any responsibility defined herein within the (Terms and Conditions) of this (Booking Form) and hold themselves legally bound and unconditionally liable to all claims herein as stipulated in this (Booking Form) and all claims made and defined by the (Organizer.
- (4) All bookings are subject to the Organizers approval. The Organizers shall have full power to determine at its sole discretion in every respect the allocation and location of the Participating Spaces and it shall be entitled for any reason which in its sole opinion is in the general interest of the Exhibition to vary the general layout or the situation and area of any particular Participating Spaces even if already allocated and the Exhibitors shall accept a new allotment of space in substitution of that originally allotted and shall not have the right to demand or receive a reduction in the Payment Amounts of the Booking Forms.
- (5) The (Exhibitor) is liable to setup the (Space Only Area) and/or (Shell Scheme Stand) Decor within the (Participating Space) as per the timings/guidelines of the (Organizer) as outlined in the (Exhibiting Guide) provided by the (Organizer).
- (6) Any electricity supply for (Space Only Areas) and/or (Designer Stands) will be billed separately to the (Exhibitor) and is not included in the price of the (Participating Space).
- (7) All forms and documentation for the <code><Exhibition></code> must be submitted in accordance with the <code><Organizers></code> deadlines as stipulated in the <code><Exhibiting Guide></code>; failure to adhere to the <code><Organizers></code> deadlines will result in the <code>>Exhibitor></code> paying an additional administration fee set by the <code>>Organizer></code> from time to time.
- (8)The Organizer reserves the right to cancel the Exhibition without notice for whatsoever reason. If the (Exhibitor) cancels their (Participation; or terminates this Booking Form/Contract, for any reason whatsoever after the prescribed date for payment of the (Payment Amount; liquidated damages will be payable by the (Exhibitor) to the (Organizer).
- (9) Oman Convention & Exhibition Centre reserves the right to re-layout the floor plan as may be necessary. Priority to choose slots in the reassigned areas shall follow the first-come-first-serve policy.

- (10) Guidelines for the ingress/egress and other pertinent information shall be communicated to the participating exhibitors 3-2 weeks before the event date.
- (11) NO CANCELLATION REFUND. Once this application form has been signed and submitted to Oman Convention & Exhibition Centre, your company agrees to pay the amount in full.
