EXHIBITOR CONTRACT TERMS & CONDITIONS

Confirmation of Space Allocation

1. The requested space allocation for the Exhibitor will be **confirmed only upon receipt of full payment** of the amount specified in the contract.

2. Non-Cancellation Clause

The Exhibitor acknowledges and agrees that this Contract is non-cancelable under any circumstances. All payments made by the Exhibitor are non-refundable.

3.Damage and Liability

The Organizer shall not be held liable for any damage to or loss of the Exhibitor's property during setup, exhibition hours, or dismantling.

4.Force Majeure

"Force Majeure" shall include but not be limited to: acts of God; flood, drought, earthquake, or other natural

disasters; epidemic or pandemic; terrorist attacks; civil war, commotion, or riot; war or threat thereof; armed conflict; sanctions; embargoes; government-imposed restrictions; denial of permits or licenses; collapse of buildings; fires; explosions; or other unforeseen circumstances beyond the control of the Organizer.

5.Refund Policy in Case of Cancellation or Postponement

In the event of venue destruction or any Force Majeure condition that renders the venue unavailable, or if the Organizer is unable to execute the exhibition leading to its cancellation, the Exhibitor shall be entitled only to a refund of payments made under this Contract. The Organizer shall not be liable for any business loss or consequential damages.

In the event of postponement, the Organizer will notify the Exhibitor at least two (2) weeks prior to the originally scheduled event date. In such a case, no refunds will be issued.

6.Internal Stall Design and Execution

Exhibitors are solely responsible for the **internal design and execution** of their stalls. This includes but is not limited to:

- Wall branding and graphic installations
- Arrangement of internal furniture and product displays

7.Binding Terms and Regulations

The Exhibitor agrees to be bound solely by the terms set forth in this Contract, which represent the mutual understanding of the parties. These terms are binding and not to be interpreted as commentary. Any breach of this Contract shall not be adjudicated at the sole discretion of the Organizer.

8.Dispute Resolution

In the event of any dispute regarding the interpretation or execution of this Contract, the parties shall first attempt to resolve the matter amicably within five (5) business days. Failing such resolution, jurisdiction shall lie exclusively with the competent courts in **Jeddah, Saudi Arabia**.
