Qualifiers will receive a light blue flat ribbon for successful pass of test. LAC will offer a "New Title" rosette for any dog finishing their title: BCAT, DCAT, FCAT.

Schedule

Test Hours: Saturday & Sunday 9 a.m. until completed.
ROLL CALL: Group 1: 9:00 a.m. Group 2: 10:15 p.m. Group 3: 11:30 a.m.
Tests will run concurrently.

Day of Test: 10:30 a.m. arrival time on Saturday & on Sunday.
Day-of-Test Entries will close at 11:00 a.m. on Saturday & on Sunday.

Course will be completely fenced in.

Fast CAT is a timed straight race of 100 Yards. Dogs run singularly

Dog's time to complete the 100-yard dash is converted into mph. Dog's time divided by 204.545 to figure MPH

18" or greater = handicap is 1.0

12" up to less than 18" = handicap is 1.5 Below

12" = handicap is 2.0

Points = MPH multiplied by the dog's handicap

FAST CAT suffix titles are earned at designated milestones:

BCAT = 150 points

DCAT = 500 points

FCAT = 1000 points

FCAT# = each additional 500 points

Timing Device: The time to complete the 100-yard dash is recorded to the nearest 1/100th of a second. The club will use break-the-beam equipment. In case of failure 2 stopwatches will be used. An individual at the start line shall signal with an arm drop at the start line. When the nose of the dog crosses the finish line the stopwatches will be stopped. The times from the two stopwatches shall be averaged to determine the recorded time.

3. Electric continuous loop machines will be used. Lures consist of white plastic bags



From the East: Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (*LIGONIER is just past DIANE St.*) (go 0.3 Miles). Turn LEFT onto AVENUE B. (*AVENUE B is just past AVENUE C*) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (*Destination is just past WATKINS AVE.*) (go 0.01 Miles).

From the West: Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981. Continue to follow LINCOLN AVE. (*Lincoln AVE. is just past DEPOT St.*) (go 0.9 Miles). Turn RIGHT onto Cedar ST. (*CEGAR ST. is 0.1 miles past CHERRY ST.*) (go 0.1 Miles). Turn LEFT onto LIGONIER ST. (go 0.3 Miles). Turn RIGHT onto AVENUE B (*AVENUE B is just past AVENUE A*) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (*Destination is just past WATKINS AVE.*) (go 0.01 Miles).

From the North: Take I-76 S (Pennsylvania Turnpike). Merge onto US-30 E via EXIT 67 toward GREENSBURG (go 18.9 Miles). Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (*LIGONIER is just past DIANE St.*) (go 0.3 Miles). Turn LEFT onto AVENUE B. (*AVENUE B is just past AVENUE C*) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (*Destination is just past WATKINS AVE.*) (go 0.01 Miles).
